#### JAMES ANDERSON

Mr. Lloyd tells us what James Anderson's log cabin was like. It had one room and one door and no windows; the floor was the bare ground. The fireplace extended all the way across one end and large logs were used which burned for several days. The chimney was built on the outside of the cabin and was made by four upright poles with vines and twigs wound around them and plastered inside with clay. A hole for the fireplace was then cut through the log walls into the chimney.

Thomas Jermain left his mill to his "daughter Mary, wife of Enoch Walker, and in default of her heirs, to George and Edward Anderson, sons of my daughter Elizabeth." James and Elizabeth must therefore have had a son Edward, not mentioned in the Family History, (p. 8).

#### PATRICK ANDERSON

Mr. Lloyd recounts the following romance between Patrick and his third wife Anna Baton (or Beaton). "Ann had come to the neighborhood to teach at the Pickering school. One day she fell into the Pickering Creek and called out for help. Patrick was nearby and attracted by her cries, came gallantly to the rescue. The result was a mutual attachment, ending in love. They desired to keep their communications secret and agreed that the hollow tree near the old Union School should serve as a post office. In this Patrick fixed a shelf and hither and thither they went to deposit or take away letters. Their secret was kept to themselves for a time but some roguish boys in the neighborhood discovered their rustic post office and abstracted the letters they found therein, informed themselves of their contents, replaced them, and scattered the news of their romance. After the secret of Patrick and Ann became known they soon married."

Patrick Anderson in his will makes a bequest to his grandson, Lewellyn Davis. His daughter, Mary, was under 18 years at that time so Lewellyn must have been a son of his daughter Elizabeth and a Mr. Davis.

#### ISAAC ANDERSON

Mr. Lloyd quotes a ditty composed by Isaac Anderson about Sergeant Dennis Dempsey who was associated with him during the Revolutionary War, and who afterwards, became a drunkard:

> "Dennis was a brave and valiant soldier, In our Revolution no one bolder To fight the British, their magog and gog But fell a martyr to his favorite grog."

The Anderson Family History has a genealogical table of only the descendants of Isaac Anderson and Mary Lane. Information of some of the other children of Patrick Anderson and their descendants has been found.

## JULIUS ANDERSON (page 8)

Julius was the oldest son of Patrick Anderson and Ann Beaton. Mr. Lloyd gives the following notes on Julius Anderson and his descendants: He was a steady quiet man who talked little and read much. He was a strict disciplinarian in his family. A tanner by trade, he became tax collector and teacher at the Pickering School and eventually a storekeeper in the little town of Scrabble, now Charleston, Chester County, Penna. He served under Capt. Davis in the War of 1812. After the British had captured Washington, entrenchments were erected along the Delaware to protect the City of Philadelphia, and Julius was stationed at Marcus Hook. His captain became ill and his place was taken by Lieut. Samuel L. Anderson. Julius took a heavy cold while in the service and it resulted in consumption of which he died.in 1822. Julius married Harriet Davies, daughter of Hezekiah, a lieutenant in the Revolutionary War. His partner in the store was Joseph Quay who married his sister, Ascenath. They were the grandparents of Senator Quay.

#### Julius' children were:

(1) <u>Jerome</u> who went to New York City to learn the printer's trade. Here he became acquainted with the Reverend Somers, a popular Baptist minister and through his influence entered the ministry. He attended Brown University and worked his way through. He preached at Newark, N. J., Martha's Vineyard, Mass., and Stonington, Conn., where his health failed. He had a son Jerome by his second wife, Catherine Douglas.

(2) Mary, born 1810, married Jacob Kosseler, millwright. They lived at Corner Stores, which is between the Anderson Farm and Phoenixville. Their children: Jerome, Lizzie, Harriet, Addie, Striker, Frances, Marion and Kate.

(3) <u>Annie D.</u> was a dressmaker. She moved to Alexandria, Huntingdon County, Penna., where her brothers Julius and Hezekiah were millwrights. She married John Biddle of Williamsburg.

(4) Adriana, born 1812, went to Philadelphia to learn to be a milliner. She married Eli Lloyd and moved to Dixon, Ill. There were three children: Julius A., Catherine E. and Anna M.

(5) <u>Hezekiah</u>, born 1814, shoemaker, later millwright; he married Drusana Biddle, sister of John, who married Hezekiah's sister Ann. They went to Dixon, Ill. His children: Mary C., Jerome B., George W., Charles A., John W., Anne E., Salome, Virginia, Frank and Homer.

(6) <u>Julius Baton</u>, (Beaton) Jr., born 1816, millwright, married Elizabeth Lloyd, lived in Huntingdon County and migrated to Dixon, Ill. Children: Harriet J. and Adriana M.

(7) John W., sailor, rounded the horn several times and had many sea adventures. Married Elizabeth Smith and finally drifted to Dixon, Ill. Children: Anna, Maria, Adriana, Charles, William, Julius and Edward.

George Claflin Harvey married Martha J. Logan on Sept. 14, 1856. She was born Aug. 27, 1838.

# THE LANES Pages 39 to 44

The date of the grant of land by William Lane to St. James Episcopal Church should be 1732 (Deed Book E page 216). The 2500 acres granted to him was a patent from William Penn in 1698. (Patent Book A volume 22 page 175.) Edward bequeathed to his son, Samuel, his residence on the west side of the Perkiomen.

William Lane, of Redclift Parish, Bristol, England, died October 11, 1705. His second wife, Cissel Love of St. James Parish, died September 2, 1704. Their children were Rebecca, Edward, Elizabeth, Joseph and William.

Edward Lane founded St. James Church in 1721. He wore silver buttons on his coat with the arms of the family engraved on them. He rode a fast black horse who was a pacer, and was shoed only on its front feet, as was the custom for horses who travelled only the woods trails. Governor Pennypacker says in his historical Notes (Penna. Magazine 1911), that Edward wore boots with round toes and at night took them off and put pumps on with peaked toes.

His wife wore a cap which she covered with a black Padesway hood so that it would not be too conspicuous, and she used pocket handkerchiefs, which was very unusual for the time; all this in spite of the fact that she was a Quaker!

Edward owned ten negro slaves.

## THE RICHARDSONS Page 50

Joseph Richardson purchased 1000 acres of land on the west side of the Perkiomen extending to the Schuylkill River in 1710. Upon his marriage his father entailed upon him a plantation of 500 acres near Germantown and the father of the bride, Sir John Bevan, gave her a marriage portion of 200 pounds. Every other month Friends' Meeting was held at his home, the alternate months it was held at the home of Lewis Walker, of "Rehobeth," located in the Chester Valley, near Valley Forge.

The descendants of Dr. James Anderson are connected with the Walkers through his wife Sarah's mother, Naomi Thomas Walker. (Pages 19 - 26.)

#### ADDITIONAL NOTES ON SUTTON FAMILY

I have recently discovered in the attic, a family Bible which formerly belonged to Mary Sutton; who she was I do not know. The Bible contains a notation that Joseph Sutton, Sr., died October 5, 1814; Joseph Sutton, Jr., died March 22, 1815. The latter is evidently not the same Joseph Sutton mentioned on pages 104-5 of the family history, who enlisted in the War of 1812 from Cranberry and was mustered out in 1817, and received a grant of land in Illinois.

It is the Joseph Sutton who served in the War of 1812, who enlisted November 18, 1814 and was discharged on March 16, 1815. He died six days after being mustered out. He received Military Bounty Land Warrant 4219 for 160 acres posthumously on April 15, 1816, for services as a soldier in the 15th Regiment U. S. Infantry, and was issued a patent to the Southwest quarter of Section 14 Township 54 North Range 17 West of Fifth Principal Meridian, Chariton County, Mo. The National Archives Director writes that, according to the record, he was 36 years old at the time of his discharge. That would agree with the family Bible which says that Joseph was born November 30, 1778. The records in the Recorder of Deeds Office for Chariton County in Keytesville, Mo. shows a deed from Henry Sutton, heir to Joseph, to John Sutton, (Dec. 11, 1851, Recorded Deed Book V, page 607). John Sutton sold the land grant to Thomas Farrgerson July 23, 1853, Deed Book 0, page 221.

The Bible contains the birth record of his children.

Joseph Junior's wife, Mary Clendennin, was born August 20, 1775. Her father Isaac Clendennin died July 11, 1830.

Correction, page 106, line 7; should be Col. Silvanus Seely.

Incidentally, our father always said that his father's brothers went to Missouri to take up a grant of land issued to their father for his services in the War of 1812, and he corresponded with a descendant of John Sutton, and a memorandum in his handwriting states his grandfather was mustered out March 16, 1815.

Joseph Sutton served as a private in Capt. Zachariah Rossell's Company; enlisted in Trenton April 20, 1812; transferred to Capt. Jacob D. Howell's Company November 18, 1814; 15th U. S. Infantry. Joseph, Sr., whose death was recorded in the Bible, must have been his father. His son born August 3, 1813, was undoubtedly the husband of Mary Riley, whom the Bible records as "widow of Joseph Sutton," and died October 5, 1835.

The Wilmington Conference said Rev. Henry Sutton was born near Princeton, N. J. There is a notation in the Sutton family bible that he was born near Kingston, N. J. This is in Somerset County not far from Princeton, which is in Mercer County.

It is interesting to note that the father of Joseph's wife, Mary Clendennin, came from Kingston (see page 106 of the Family History for the account of her father, Isaac Clendennin).

The result of an exhaustive search of the records in New Jersey by professional geneologists shows that our great grandfather, Joseph's father, was Joseph, and his father was Henry Sutton of Piscataway, Middlesex County, New Jersey, who died December 10, 1805, and left to his son Joseph 20 pounds and to Joseph's son, Samuel, 20 pounds. Joseph had three sons, according to our father. Henry married Mary Langstaff in 1751.

Henry's father was Joseph, who died October 23, 1754, and is designated in his will as a "yeoman," of Piscataway, and left 19 acres to his son Henry after the death of his father, Thomas. It is stated in his will that his son Henry lived in Woodbridge. That is a town near Piscataway, in Middlesex County, where lived the original William Sutton who moved there in 1672. (See page 103) William was an elder of the Quaker Meeting located in that town and was buried there.

William had a son Thomas (born 11/11/1669) who married Mary Adams of Woodbridge in 1693. They had a son Joseph, born in 1694, who was probably the Joseph who died in 1754. Thomas and Mary lived in Piscataway.

The search has proved that Daniel Sutton, buried in Burlington (p. 103) was not an ancestor of ours.

I have recently heard from Dr. Edward F. Sutton of Amenia, New York, a retired physician, that William Sutton, who settled in Piscataway, New Jersey, and purchased land there in 1685, was not the son of John Sutton as alleged on page 103 of "<u>The Family History</u>." Dr. Sutton has written a book on the family. He informs me that Richard C. Sutton of Brandon, Vt., (see page 113) is reliable, and that his statement that William Sutton's father was George is probably correct. It appears that George settled in Scituate, Mass. in 1634 and John Sutton settled in an adjoining town. George, with most of his family, migrated to North Carolina, and John soon after moved to Scituate. That is how the confusion occurred.

George sailed from Sandwich, England, with the party of Nathaniel Tilden of Tenterden, Kent, as a servant of the party. That does not mean, however, that he was of the household servant class, as he married Nathaniel's daughter Sarah soon after their arrival in this country. He probably worked his passage over by serving the Tildens.

Nathaniel Tilden was a man of distinction and of good family. He was chosen Ruling Elder in the Church in the new colony. In 1622 he was mayor of the Boro of Tenterden, England. He emigrated with his wife Lydia and seven children and seven servants, and heads the list of "such persons as embarked themselves in ye Good ship Hercules of Sandwich, 1634." He was born July 8, 1585 and died in 1641. His brother was one of the merchants of London who fitted out the Mayflower.

George Sutton married Sarah Tilden in 1641. Nathaniel was the ancestor of William J. Tilden who was elected President of the United States by popular vote. Nathaniel was descended from Sir William Tilden De Sittenbowne and Congleton Chesire "who fought in ye van of ye English Armie commanded by Lord Audley under ye Black Prince in ye Battle of Poictiers, Anno 1356." (From William Camden, Antiquarian.) George and most of his family migrated to Perquimans County, North Carolina, which is on the Virginia border. Tilden is notable for having introduced honey-bees into this country. It is said that there were previously no honey-bees in North America.

#### THE CRAIGS

Our grandmother, Ann Craig, was born January 1, 1798 and died in 1884 in her 86th year. It may be remembered that father said his mother's parents both died of Yellow Fever.

In the Family History, page 104, our greatgrandfather's name was said to be James. This appears to have been an error. My son Crawford recently made a search of the records at City Hall, Philadelphia, and found a Petition by Mary and Ann Craig in 1812 (Docket 24 page 95) in which it was stated that the petitioners were over 14 years of age and have no guardian, and asked the Court for a privilege to choose one. William C. Parker was chosen guardian and he asked the Court to audit the account of John Willis, administrator of George Craig, father of Ann and Mary.

It may be remembered that father said that his mother's uncle handled the estate and that there was a shrinkage. The auditors found that he had given no credit for nearly 14 years interest on the sum of 305 pounds and other discrepencies.

According to the record there was also a son John, but he does not appear in the proceedings for a guardian and it may be that he was not living at the time. The amount of the estate was 613 lbs.,9 shillings,  $4\frac{1}{2}$  pence.

Crawford then made a search at the Pennsylvania Historical Society and discovered on the records of those who died from Yellow Fever in this city, the name of George Craig, who "died September 3, 1798, Methodist" and "George Craig's wife died August 3, 1798." Ann Craig Sutton's mother died, therefore, when Ann was seven months old.

Dr. Sutton has written a book on the family. He says that Richard C. Sutton of Brandon, Vt., (see page 113) is reliable, and that his statement that William Sutton's father was George is correct. It appears that George settled in Scituate, Mass., in 1634 and John Sutton settled in an adjoining town. George, with most of his family, migrated to North Carolina, and John soon after moved to Scituate. That is how the confusion occurred.

George sailed from Sandwich, England, with the party of Nathaniel Tilden of Tenterden, Kent, as a servant of the party, on the ship "Hercules." That does not mean, however, that he was of the household servant class, as he married Nathaniel's daughter, Sarah, soon after their arrival in this country, i.e., on March 13, 1636. He probably worked his passage over by serving the Tildens. He was born in 1613.

Nathaniel Tilden was a man of distinction and of good family. He was chosen Ruling Elder in the Church in the new colony. In 1622 he was mayor of the Boro of Tenterden, England. He emigrated with his wife Lydia and seven children and seven servants, and heads the list of "such persons as embarked themselves in ye Good ship Hercules of Sandwich, 1634." He was born July 8, 1585 and died in 1641. His brother was one of the merchants of London who fitted out the Mayflower.

George Sutton married Sarah Tilden in 1641. Nathaniel was the ancestor of William J. Tilden who was elected President of the United States by popular vote. Nathaniel was descended from Sir William Tilden De Sittenbowne and Congleton Chesire "who fought in ye van of ye English Armie commanded by Lord Audley under ye Black Prince in ye Battle of Poictiers, Anno 1356." (From William Camden, Antiquarian.) George and most of his family migrated to Perquimans County, North Carolina, which is on the Virginia border. Tilden is notable for having introduced honey-bees into this country. It is said that there were previously no honey-bees in North America.

## WAR RECORD OF COLONEL JOSEPH AUBREY SUTTON

Col. Sutton enlisted in World War I on May 20, 1917, as a private. He was assigned to the First Division, the first American unit to go overseas, June 5, 1917. In France he was made Top Sergeant becoming a machine gun expert, and was assigned to General Pershing's Headquarters at Chaumont where he was commissioned First Lieutenant, serving as a special assistant to General Mosely, G4. He was later put in charge of the Automatic Arms Division under General Williams, Chief Ordnance Officer of the American Expeditionary Forces, and continued in that position until the end of the war, advancing to the grade of Captain.

At the conclusion of the war he was appointed to the Armistice Commission and accompanied some of the first American troops into Germany. Later Sutton was chosen by the General Staff as their representative on a special mission to Italy. Following this mission he was assigned to the French National Military Academy at St. Cyr, where he was appointed by General Tenant, the French General in Command, as a member of the faculty and professor of Small Arms and Automatic weapons. At the close of the academic year he returned to this country and was commissioned a major in the U. S. Reserves.

During World War I Col. Sutton was decorated by the Italian Government with the Order of Monta Graffa, and by the French Government with the Croix de Guerre.

At the beginning of World War II Major Sutton was recalled to active duty and placed in charge of Ordnance activities at Camp Forrest, Tenn., and later at Fort Jackson, S. C., advancing to the rank of Lieut.-Colonel. In 1943 he was ordered overseas to the China-Burma-India Theatre. There he first served as Assistant Theatre Ordnance Officer and special aide to the General Staff at General Stillwell's Headquarters, New Delhi, India. In this capacity he participated in the Burma campaign. When Operation China Theatre was formed, Col. Sutton was appointed Special Ordnance Advisor to the Chinese Armies in the field, and as such participated in two successful Chinese offensives: The Burma Road Campaign, which culminated in the battle of Wanting and which reopened the Burma Road; and the Defense of Chickiang with the successful Chinese counteroffensive, the last major engagement before V-J Day.

At the conclusion of hostilities Col. Sutton was put in command of a U. S. Battalion which he flew into Shanghai; it being the first American armed force to enter, and took over that city from the Japanese. In December 1945 he returned to this country and was commissioned Colonel in the U. S. Reserve.

While in China, Col. Sutton was cited for outstanding service in Special Orders of the Chinese Ordnance Department. He received a joint Commendation signed by Gen. McClure, U. S. Commander of the Chinese Combat Command, and General Ho Yng-Chin, Chief of Staff of the Chinese Supreme Command. Subsequently he received the Special Breast Order of Yun-Hui, on command of Generalisimo Chiang Kai-Shek, for the Chinese Government.
