NOTICE.

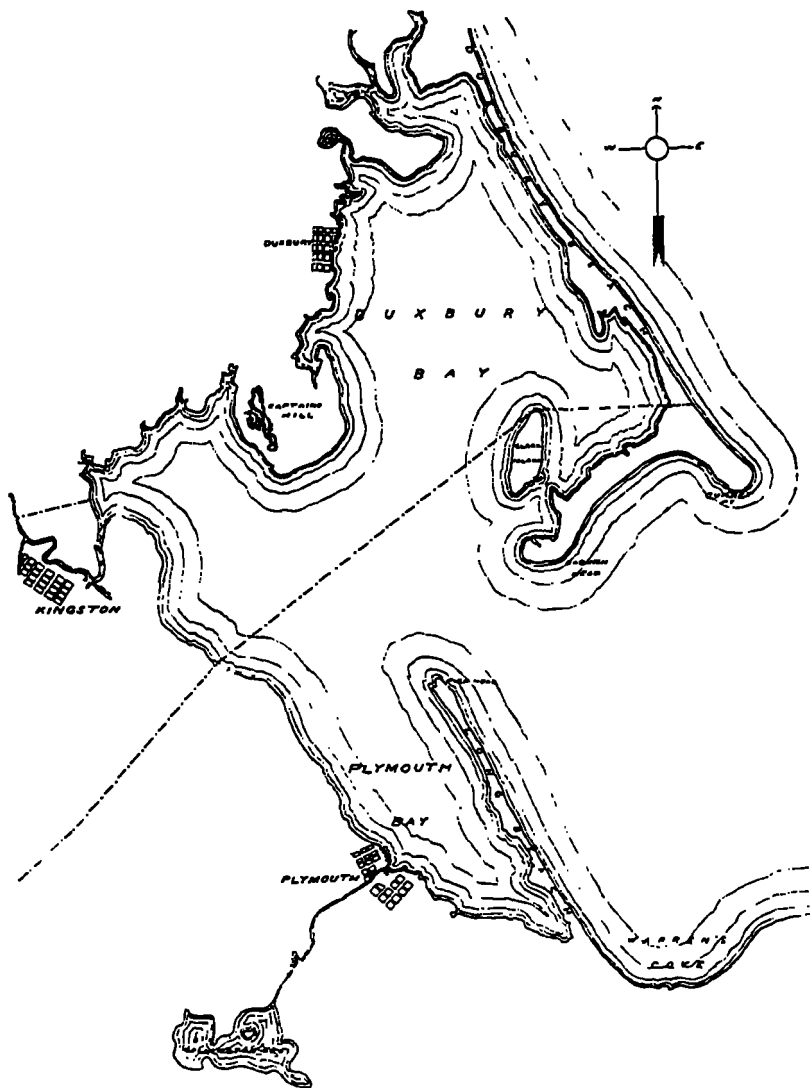

EXPLANATION.

b. born; d. died; bap. baptised; m. married; unzm. unmarried; gen. generation.

All members of the second gen. are numbered in the 200, of the third gen. in the 300, of the fourth gen. in the 400, and so on. Where the numbers were not sufficient a letter of the alphabet is added.

To trace a line look first to the index at the back of the book—say for Edward. The index will give the page on which the name is mentioned. On the page you will find “580 Edward.” Just above you will find that he was one of the children of Levi 496. Turn to 496 in heavy black type at the left of each page and you will find all information of Levi. Just above you will find that Levi was one of the children of Job 362. By turning to 362 you will find that Job was one of the children of James 208, and James a son of the emigrant Thomas 101. This system of numbering makes it an easy matter to go forwards or backwards with any line.

POLITICAL HISTORY.

COMPACT SIGNED IN THE CABIN OF THE MAYFLOWER.

IN Y^e NAME OF GOD, AMEN.—We whose names are under-written, the loyall subjects of our dread soveraigne Lord King JAMES, by y^e grace of God of Great Britaine, France & Ireland King, Defender of the Faith, &c.

Haveing under-taken for y^e glorie of God, and advancemente of y^e Christian faith, and honour of our King & Countrie, a voyage to plant y^e first colonie in y^e northerne parts of VIRGINIA, doe by these presents solemnly & mutually in y^e presence of God and one of another, covenant & combine our selves together into a civill body politick, for our better ordering and preservation, & furtherance of y^e ends aforesaid; and by vertue hearof to enacte, constitute and frame such just & equall lawes, ordinances, acts, constitutions & offices from time to time, as shall be thought most meete & convenient for y^e generall good of y^e Colonie; unto which we promise all due submission and obedience.

In witness whereof we have herennder subscribed our names at Cape Codd y^e 11 of November, in y^e year of y^e raigne of our soveraigne Lord King JAMES of England, France & Ireland y^e eighteenth, and of Scotland y^e fifty-fourth Ano Doin. 1620.

The Mayflower pilgrims spent the first Sunday—December 20th, 1620—on Clark's Island, and the next day landed at Plymouth. The company had 102 members, about one-half of whom died during the first winter.

1623. Trial by jury was first instituted in Plymouth county.

1631. The first parish was built in Plymouth county.

1752. New style of dates commenced.

1765. March 8, Parliament passed the Stamp act.

1765. Oct. 7, Colonial Congress met in New York.

1766. Mar. 18, Stamp act repealed.

1767. June 29, Parliament passed bill taxing tea, glass, paper, etc.
1768. Mass. assembly petitions the King against the tea tax.
1773. Inhabitants of Boston throw 342 chests of tea into the sea.
1774. March 31, Parliament passed the Boston port bill.
1774. Sept. 5, the first Continental Congress met in Philadelphia.
1775. April 10, Battle of Lexington.
1776. Declaration of Independence signed by 13 states.
1777. Dec. 16, Independence of U. S. acknowledged by France.
1781. Feb. —, Articles of Confederation ratified by the States.
1782. Oct. 8, Independence of U. S. acknowledged by Holland.
1782. Nov. 3, Temporary Treaty of Peace signed in Paris.
1783. Sept. 3, Treaty of Peace signed at Paris.
1783. Nov. 3, American army disbanded.
1783. Nov. 25, New York evacuated by the British.
1783. Dec. 19, Charleston evacuated by the British.
1787. Sept. 17, Constitution adopted by all states except Rhode Island.
1789. First Congress of the U. S. Ten amendments to the Constitution passed.

SPELLING OF THE NAME

In France the name appears as Bonay, Bonny, Bonney and Bonnay. In England the name appears as Bonny and Bonney. Its first appearance in America is in the certificate of the emigrant from the church at Sandwich, England, as Boney and it so appears in the emigrant's will, signed by mark, but in the proof of the will and the endorsement on the back of the same is Bonney. Thomas 2nd is described in his will as Boney, which is also signed by mark. John is the first to write his own name to a will and he signs as Bonney. William is described in the letters of administration as Boney. Joseph is described as Bonny in his letters. James, appears in his letters as Bonney which spelling is generally followed by the subsequent generations.

FIRST GENERATION.

101. THOMAS BONNEY (also called Goodman Bonney) was the first of the family in America. He was an emigrant in the ship *Heracles* of Sandwich, England. This boat was of 200 tons, John Witherley, Master. "Bound for the plantation "called New England in America with certificates from the "ministers where they last dwelt, of their conversation and "conformity to the orders and discipline of the church and "that they had taken the oath of allegiance and supremacy.

1642. In August the number of those in each town between the ages of 16 and 60, able to bear arms, was ascertained by the court, and their names recorded. Those of Duxbury were: Thomas Bonney and others.

1643 to 1644. Thomas Bonney was a constable at Duxbury. "This was an office of high trust and responsibility and none "were elected to it but men of good standing." Winsor.

1652. Thomas Bonney was a surveyor of highways.

1691. The town record says: "Town did agree that "Goodman Bonney should have a paire of shoes bought with "part of the rent dew for the comon meadows."

"Perez Bonney's chronicle of his predecessors and likewise "his own posterity—from his grandfather down to his own "grandchildren.

"I, the subscriber, Perez Bonney, the son of John Bonney, "of Pembroke, having a mind to write an account of my "predecessor, according to the best information that ever I "had, I shall begin with my grandfather. Thomas Bonney, "who came from Dover, in England, and was born about the "year 1604, and married Mary Terry, but she died, and then "he married Mary Hunt, being as I have been told about 50 "years old by whom he had:

Bodge's history of King Phillip's War, says:

Page 406. " It will be remembered that when, on Decem-
 " 10th. 1675, the forces of Massachusetts Colony were must-
 " ered on Dedham Plain, to march against the Narraganset
 " fort, a proclamation was made to the soldiers, in the name
 " of the governor. that ' if they played the man, took the fort
 " and drove the enemy out of the Narraganset country, which
 " is their great seat, they should have a gratuity of land, be-
 " sides their wages.'

" We find that after they had performed the service, and
 " the war was long past, the soldiers were not forgetful of
 " their claim, nor the colony unmindful of its obligation.

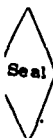

CHILDREN OF THOMAS 1ST.

201. Thomas of Duxbury married Dorcas Sampson, daughter of Henry Sampson, who came in the Mayflower with his uncle Edward Tilley but who was to young to sign the compact and had Ebenezer 301. Thomas 302. Elizabeth 303 and Mercy 304.

Possibly he, 2nd. m. Sarah Studley, in 1695.

1690. Thos. Bonney, Jr., "hired common meadows of the town."

1703. Measures to divide the common were deferred on the remonstrance of Thos. Bonney and others.

1707. Sep. 12. It was voted to every freeholder and house keeper twenty acres of the commons.

1710. Jan. 30. It was voted that each proprietor of a lot, if he has been a townsman ten years, should have forty acres, or enough to make up to forty acres.

An examination of books in the British Museum, London, did not show that the family had any history in England prior to the time Thomas Bonney emigrated to Duxbury.

Mr. Geo. P. Bonny of London writes: "I have not been able to ascertain any particulars re History of the Family unless the enclosed from The World of Wonders which a Cousin of mine found among some Waist paper should relate to it. The Anne Bonny Female Pirate therein referred to appears to have escaped hanging which is perhaps some consolation.

The inclosure after describing a Mary Read says: "Anne Bonny was born in the County Cork where her father was an attorney. He deserted his home and Emigrated to Carolina, taking Anna with him. Here she incurred his displeasure by marrying against his will, and being turned out of doors found her way to the island of Providence where she made the acquaintance of a pirate captain named Rockam. On board his ship she fell in with Mary Read.

"Anne Bonny showed courage to the last. The pirate captain having been admitted to see her, by special favor, on the day he was to be executed, she told him contemptuously that "if he had fought like a man he need not have been hanged like a dog."

The enclosure says: "they lived about one hundred and fifty years ago.

SIR: I have examined the various authorities respecting the Bonnay pedigree, and am of opinion that altho' the link does not appear there is not much doubt that your family is the same with that of De Bonnay, the translation of whose pedigrees you have. Also Haag says that one branch professed Protestantism. Then again one member of the family was in favor with Henry IV. a strict protestant. Nothing is easier or more common than for some one of the name to have come over to this country, possibly in the suite of some ambassador, and to have stayed here in order to remain in the peaceable enjoyment of his reformed religion. BONNEY FAMILY IN FRANCE.

Histoire Généalogique et Héraldique des Pairs de France. By M. le Chavalier de Courcelles. Paris 1824. Vol. III. Article DE BONNAY. Lords, then Counts, afterwards Marquis de Bonnay, Peers of France, in the Nivernais. Arms: Azur on a chief or: a lion crowned gules, overtopping all the rest. Supports, two griffins. Motto: NEVER SWERVE.

The family of de Bonnay took its name from an estate situated in Berry, on the borders of the Bourbonnais. Its antiquity, which goes as far back as the days of chivalry, is established by charters of the date of 1111, during which period lived John, lord of Bonnay. His son Hugh, lord of Bonnay, was witness in 1147 to a charter granted by William III, Count of Nevers and Auxerre, in favour of the Priory of La Charité. We give here the genealogy of the family of de Bonnay after the documents furnished to the office of the Saint Esprit in 1783, before M. Chérin, genealogist to the King.

I. ARNOLD, first of the name, lord of Bonnay, Knight, brother of Constantine de Bonnay, page, who, in the year 1298, repurchased a fief (freehold), situated in his tenure, and the 29th of August, (St. Bartholomew's Day) 1293, concluded a transaction with the Abbot and monks of the Maiso-Dien, on the Cher, (afterwards called the Abbey of Noirlac) near St. Amand, in Berry, on the subject of an annuity which this said Lord de Bonnay owed to these monks, on account of Radin du Saulzay, his father-in-law. Arnold de Bonnay had married in 1263 Jane du Saulzay, who in the above deed of 1293 is described as deceased.

By her he had two sons:—

1. William, see next article.

2. John de Bonnay, who lived in 1308 and was father of:— Girard de Bonnay, Esquire, who died at an advanced age, after 1386, leaving with other children, John de Bonnay, Knight banneret, lord of Meneton-Salon and Ville-neuve-Comtal, Chamberlain to Charles VI and Charles VII, Senechal of Toulouse from 1415 to 1418, when his devotion to the Dauphin, afterwards Charles VII, during the unfortunate quarrels between Burgundy and Armagnac, caused him to be deprived of that post by the Queen, Isabella of Bavaria. In May of the preceding year John de Bonnay had distinguished himself at the Siege of la Réole, against the English, at the head of the militia. He then defended the castle of Buzet on the Tarn, and was solemnly reinstated in

his post of Senechal of Toulouse, by the Dauphin, then regent of the Kingdom. March 4th, 1419 (old style), the same prince, having come to the throne, appointed John de Bonnay, January 5th, 1424, to serve in Languedoc, at the head of 80 men at arms, and 40 javelin men, under the command of the Count de Foix. The following year he commanded three knights bachelor, 76 esquires, or equerries, and 40 archers; and in 1426 had the command of 100 men at arms (500 horses). In October, 1435, he defended Castel-Sarrasin against the English, and again performed the duties of Senechal of Toulouse in 1439 (*Histoire Générale de Languedoc*, by D. Vaissete, t. IV, pp. 445, 446, 451, 465, 466, 483, 489). John De Bonnay married December 21st, 1421, Jane de Montesquiou, daughter of Arsieu Baron de Montesquion, and Gaillarde d'Espagne de Montespain by whom he had Jane de Bonnay, who married Hugh, Viscount de Carmain.

II. WILLIAM, Lord de Bonnay, a page, and John de Bonnay, his brother, pledged their faith and did homage, the Thursday after Trinity (29th May) 1308, for certain tithes for the estate of Bonnay, of which they were joint possessors, to Raoul Chaillon, Lord of Cluzet. The name of Arnold's wife (Agnes) is not known, but it is known that he was the father of Arnold II, who follows.

III. ARNOLD, 2nd of the name, knight, lord of Bonnay, Pongues, Bermien, Chazerat and Champallement, in the Nivernais, acquired various estates in 1336 and 1334. He served against the English, fought, August 26th, 1346 at the unlucky battle of Crécy, where he had a horse killed under him and at the end of which he was knighted. In 1369 he served King John at the head of a company of 12 esquires, and on the 12th, of August in that year he gave a receipt for his military salary which he sealed with his armorial seal. He is styled *Marshal of Berry*, in a deed of 1st February, 1371, relative to a commission which he had to review 50 men at arms which had been raised for the defence of that province. June 27th, 1374, Arnold de Bonnay was present at the marriage of Berand, Dauphin of Auvergne, with Margaret, daughter of John Count de Sancerre, and he died before February 11th, 1385. He had married in 1356 Isabella of Sancerre, lady of Précy and Meneton Salon, daughter of Louis of Sancerre, lord of the same places, and June de Mornay, lady of Saint Cyr of Précy and of Boissière.

From this marriage issued:

1. Robert, lord of Bonnay, Meneton-Salon, of Garde, of Bussière, and of Quantilly, Knight bachelor, hereditary Marshal of Berry, bailiff of Mâcon, and Senechal of Lyons. He

served in the armies of Kings Charles V. and VI., with companies more or less numerous formed of knights bachelors and squires, and was, in Languedoc and in Guienne, lieutenant of Louis Champagne, Count de Sancerre, Marshal and Constable of France. Robert de Bonnay was styled *Marshal* of the army of that prince (doubtless as Marshal of Berry) in a deed swearing fidelity, made in his presence, 5th March, 1391, by Guichard Dulphe, senechal of Quercy, to Aimeri de Peyrat, Abbot of Moissac. (Hist. de Languedoc, Vol. IV, p. 404.) Robinet, lord of Quantilly, having no children, made Robert of Bonnay heir to all his property. The latter was still living on February 24th, 1414.

2nd. Philip 1st, who follows afterwards :

3rd. Peter de Bonnay, who served as esquire in 1386, in the regiment of Marshal de Sancerre.

IV. PHILIP, 1st of the name, lord of Bonnay, Pongues, Bermieu, Précie &c., Knight, Chamberlain to King Charles VI., bailiff of Mâcon, and Senechal of Lyons after his eldest brother Robert, is styled in his deeds as a *noble and powerful man*. He commanded, October 1st, 1379, a company of two knights bachelor and six esquires. In 1396 he made a compromise with his brothers; made an acknowledgment as possessor of the manor and stronghold of Précy, and was living in 1415. He had married, by contract of January 11th, 1385, Galianne de Montnuc, daughter of Stephen de Montnuc, Knight, Lord of Meance, by whom he had amongst other children :

1st. Pierre, who follows :

2nd. Arnold de Bonnay, who was father of Colombe of Bonnay, wife of Renaud de Dormans, Knight, lord of Nozay. Saint Rémy and Herpont, Master of Requests, Ambassador from the King to Rome, died November 11th, 1472, son of Peter de Dormans, lord of Nozay, and Margaret de Lonan. Colombe de Bonnay made her will January 14th, 1478, and died the same year.

V. PETER, first of the name, lord of Bonnay, Pongues, Précy, Bermieu, Savigny, &c., Knight, styled *noble and powerful lord* in various deeds registered during the years 1437, 1439 and 1444, was no longer living May 23rd, 1460. He had married in 1435, Jane de Graçay, daughter of John de Graçay, lord of Maisonfort. He had six sons, only three of whom are known,

1st. John, Lord of Bonnay and Précy, Knight, died without issue :

2nd. Philip 2nd who follows :—

3rd. Pepin de Bonnay, squire, lord of Pr  cy and Coudray, living in 1483. He married Catherine de Changy, by whom he does not appear to have had any children.

VI. PHILIP DE BONNAY, 2nd of the name, squire, lord of Pr  cy and of Bessay, styled *noble and powerful lord*, married in 1452, Perronnelle de Demoret, daughter & sole heir of Philip de Demoret in the Bourbonnais, and of Margaret de Sully, lady of Bossay. Philip died young, before his father, leaving issue of his marriage :—

2nd. Jacqueline de Bonnay, married in 1475, to Hugh le Long, lord of Chenillac and Fongis.

VII. PETER, 2nd of the name, lord of Bonnay, Pr  cy, Pongues, &c. knight, councillor and Chamberlain to John and Peter, dukes of Bourbon and Counts of Auvergne, came to a compromise, in 1453, with Pepin de Bonnay his uncle, on the subject of the heritage of Peter 1st, lord of Bonnay, his grandfather, and died November 21st, 1533, aged 84 years. X. EDMÉ DE BONNAY, Knight, lord of Demoret, married Antoinette Damas d'Aulezy, daughter of John Damas, 4th of the name, Baron d'Aulezy and Crux, knight, lieutenant for the king in the government of the Nivernais, his gentlemen in ordinary, an ensign in the company of the Count de Nevers and of Edmée de Crux. By her he had:—

IX. ANTOINE DE BONNAY, 1st of the name, squire lord of Bessay, Buy, Jay and Montlevé, lieutenant for the king in the arsenal of Picardy, is mentioned in the deed by which, on the 9th, January, 1571, his father and mother divided their property between him and his younger brother, Francis. He made his will the 20th and died the 25th day of July, 1588. He had married by contract, September 9th, 1574, Anne de la Perrière, sister of Jacqueline de la Perrière wife of Peter 3rd de Bonnay, lord of Demoret. By her he had:—

*NOTE.—Thomas de Bonnay and Edme Paul his brother, having followed the fortunes of the Dukes of Savoy, even during their quarrel with France, nearly always made Turin the place of residence, and here they lived in great magnificence. During their absence their affairs fell into disorder and their lands were seized, so that Antony de Bonnay, son of Thomas, was obliged to sell the greater portion of them in order to pay his father's debts, and nothing was left for Henry de Bonnay, his son, but the two small estates of Quenouille and Preale. Thus during more than 100 years the descendants of Thomas de Bonnay were reduced too low to permit of their occupying the rank at court and in the army which their ancestors had occupied till then. Charles Francois de Bonnay, born in 1750, was the first to begin to restore his family to their former illustrious position.

The 20th of December, 1580 he compounded with the lord of St Gérán. He had married Mary Damas d'Anlezy, daughter of John Damas 3rd of the name and Jane de Bar de Bangy. She died August 4th, 1626, leaving:-

BONNAY.

The Bonnay family came originally from Franche Comté, one branch of it which settled in Champagne professed Protestantism.

Henry de Bonnay, author of this branch, left of his marriage with Anne de Breuil, a son named Adrien, who married Jane de Gadières, by whom he had Angrand de Bonnay, living at the beginning of the 17th Century. He married Christiana de Foucault, who brought him five sons:—
