Stated John Boyd locatd in Putnam Co Tenn fall of 1815, and thereafter lived in same county until he died prob 1845, his wide Elizabeth lived to age 97. She died in the early 80's- her post office address was Pekin, Putnam Co Tenn.

Elizabeth Boyd made one application 1850 Nov 2 in SMITH COUNTY TENNESSEE age 65 then but stated she was a BOYD PENSIONS

My own age I do not know for my father died a short time after and therefore my age was not kept - the record of my marriage was destroyed in time of the late war. My post office address is Mr New Market, Jefferson Co Tenn She stated her husband applied for land warrant and received same 1850. Several affiants from Hawkins Co Tenn gave depositions that they had known Wm and Elizabeth Boyd for many years, one was Jacob Leonard, and Elizabeth Roberts.. Affidavit of Henry Boyd in Jefferson Co Tenn

BOYD PENSIONS (was)? the word was is written twice or 1875 states he was not an eye witness to the marriage of the word "not" one or the other, but illegible. William Boyd and Elizabeth Bresentine and that said marriage took place in the year 1813 November. I, Henry Boyd haehave no interest in the claim, I, Henry Boyd was born 1802 22 August.. Affidavit of Jacob Leonard state he has been acquainted with them 62 years ago, - this was made 1876 - I was born and raised a near neighbor to Wm and Elizabeth Boyd until about 1860 I moved to Jefferson Co Tenn and went back to visited Elizabeth Boyd until she moved down near me, have known her all my life.
