INTRODUCTION.

RESEARCH PROMOTED BY WILLIAM W. BLIVEN, ESQ.

William W. Bliven, Esq., New York, began a research for the genealogy of the Blethen family, thinking that the Blethens and the Blivens were of the same ancestry. But after much correspondence with Blethens and officials, and the expenditure of seventy-five dollars in cash, he came to the conclusion that he was not on the track of his ancestors.

His correspondence had brought him in touch with Colonel Alden Joseph Blethen, President of The Times Printing Company and Editor-in-Chief of The Daily Times, Seattle, Washington, who paid Mr. Bliven his cash expenditure for Blethen genealogy and took upon himself the work of co-ordinating and publishing the material collected.

Among others, Mr. Bliven, in 1896, employed Mary E. Arvedson, Assistant Librarian of Essex Institute, Salem, Massachusetts, and George Arvedson, "Competent Guide to Salem, Massachusetts," to make researches in Salem, Lynn, Boston, etc., in public and private records and libraries.

As the older generations of Blethens were members of the Society of Friends, and as it was the tradition that their immigrant ancestor was a member of that sect and lived in Massachusetts, Mr. Arvedson examined the an-

cient records of the Quakers at Lynn, Massachusetts. The Friends were extremely careful of their ancient documents and had them preserved in a safe in their church. After several unsuccessful attempts to get access to them he finally succeeded and on the first day found nothing, except, as he passed a book back to the watchful custodian, he saw the names "John and Jane Blethen" and reference to something they had done wrong. His second attempt he relates as follows:

Salem, July 10, '97.

Wm. W. Bliven, Esq.

Dear Sir: I have just returned from Lynn, Mass., where I have just put on another day at the terrible old I thought everything was arranged; that the records. new man would open the safe at once. He was in doubt The records are so valuable, he what was best to do. did not like to take the responsibility. I told him I had seen the other two who had charge; that I had the young lady, who was well known in Lynn, to look after their interest; and then there were men at work replacing the seats, one of whom was a Brother Quaker. I told him if he got through before I did that I would pay him for the extra time he would have to stay. I began to think that the prospect of what might be before me was lost, just as he got the safe open and very reluctantly passed one book. As it was the one I had been through, no more until it was passed back, when the true old Quaker came in and I had it to suit me. It was nothing but perseverance that conquered. I soon got the right side of the man who was at work, by speaking of a name that turned out to be one of his ancestors over two hundred years ago. He then says: "That work you are doing is as much of

a trade that takes time to learn as his trade of a carpenter."

The first I found-Marriage Certificate-1704-5:

"Elizabeth Blethen, dau. of John Blethen (and) Isaac Chase of Swansea.

and quite a number of other names.

Geane Blethen, one of the witnesses.

He examined the Quakers' Quarterly and Monthly Record Book (in bad shape).

"At our men and womans meeting held at Joseph Boyces house the 6th day of the 5th month, 1680, a committee of Daniel Southwick and Bro. Gaskill go to John and Jane Blethen and others and to deal with those contrary spirited people for their disorderly walking and keeping on their hats and continuing sitting in the time when Friends of Ministry are at prayer to Almighty God, and other disorderly things which the above said people are guilty of, which is contrary to the truth and practice of the Lord's people and so you are desired to return their answers to the next monthly meeting held in house of Joseph Boyce."

"Salem, 6th day, 6th month, 1680, the Committee reported left them very stubborn and obstinate refusing to give plain answers according to the truth, except John Blethen, who gave some small satisfaction upon which Josiah Southwick and Bro. Gaskill was desired by the meeting the same time while the meeting sat, to go to John Blethen for a further satisfaction to whom his answers, which was done accordingly, and Josiah Southwick and Bro. Gaskill answer was as follows: 'We have been with John Blethen, he will give us no satisfaction or either will he acknowledge that he hath done anything contrary to the truth.'

"One of the attendants at the meeting at house of Sam Collins, Lynn, 18th day 5 mo. 1689, was John Blethen. Thomas Maul lay before this meeting his aggrievances sustained by Jacob Allen in his business relating to his vessel. John Blethen and Daniel Southwick is desired and appointed by the meeting to go to him and know his mind whether he will come to any agreement freely, without any further trouble & so may be decided without going to Law, or either to lay it to the judgment of friends and buy vessel wholly to himself or else to sell his part to Thos. Maul. John Blethen & Daniel Southwick, is decided by the meeting to return their answer the next 7th day ensuing the above date."

Among the Record of Quakers at Lynn, Mass., there is a record of a Quaker Meeting held at the house of Samuel Collins May 18, 1689, when the following named persons were present: Thomas Maul, Daniel Southwick, John Blethen, William Williams, Samuel Gaskins, Jr., Samuel Collins, Thomas Graves, Edward Gaskins and James Goodridge.

Mr. Arwedson next notes in his letter the following entries:

"28th 5 mo, 1689.

To our friends & brethern in Rhode Island or elsewhere. (Signed by) Rob't Stone, Sam Robinson, John Thomas Graves, Wm. Williams, Tho. Maul, James Goodridge, Josiah Southwick, John Blethen.

Lynn, 13th 7 mo, 1689, house of Sam Collins. John Blethen with others took principal part in all meetings; this to raise a contribution for hire of travelling Friends horses and house. amount raised 28 shillings.

John Blethen and Dan'l Southwick to go to Jacob Allen to give satisfaction & a paper of condemnation to the world to clear the said James Goodridge from those slanders cast upon him.

A public testimony was given against Jacob Allen in connection with James Goodridge above."

"A meeting was held at Newport, R. I. 4 mo, 1700."

"A meeting was held 8-6, 1689, at John Blethen's and a certificate granted to well beloved friend James Goodridge."

"From this time the name (John Blethen) goes out of existence, although there are quite a number of leaves gone soon after this date."

"I believe I have given you everything at last that I can find.

"I was a little surprised to find: 13, 3, 1714, upon the building of a new meeting house in Salem, permission had to be asked for from the Friends Society in Rhode Island.

In the name of God, Amen. I, John Blithen, Sr. of Salem in ye County of Essex in N. E. doe make & ordaine this my Last Will and Do Admit being sick & weak in body but sound & of perfect memory and of a Disposing mind,

First & principally I resign my soul into ye hands of Almighty God that gave it and my Body I recommend to ye Earth to be Decently buryed by ye Discretion of my Executor here named and as for my worldly estate which ye Lord hath Lent me I give dispose in manner & form following: Item I Give unto my well beloved wife Jane Blithen the one half of my Real Estate during her natural Life & after her decease to my Son John Blithen & his heirs for ever - - -

Item I Give unto my Son John Blithen the other Halfe of my Real Estate after my decease to be to him & his heirs forever.

Item I give unto my five daughters namely Jane, Elizabeth, Sarah, Abigaile & Hannah, Seven pounds a piece to be pd by my son or such as by Improvement the Estate shall produce within one year after my decease to them of my daughters yt are of age and to you which are not within one year after they Come to age.

Item I Give unto my said Wife the whole of my movable

Goods or Estate during her widowhood but If she should be married & change her Condition then the Said movable goods to be Equally Divided between her & my son John.

Item I appoint my Loving wife & my son John Blithen Joynt Executors of this my Last will & that they pay Equally between them all my Just Debts & funeral Charges Revoking all other former wills here to fore made or Done. In Testimony whereof I have hereunto put my hand & seale this Eight day of November 1704.

The reader will notice that the latest mention that Mr. Arvedson found of John Blithen's name in the Record of Quaker Meetings was 4th month, 1700 (some pages missing).

His will is recorded in Salem public records. He signed it Nov. 8th, 1704. It was proved before Hon. John Appleton, Judge of Probate of Wills, Feb. 19, 1705. And the inventory of his estate was signed Feb. 17, 1705. So it seems that John Blethen left his physical body not a long while after his name disappeared from the record of Quaker meetings.

While the date of his death may thus be placed between Nov. 8th, 1704, and Feb. 19, 1705, the date of his birth was not ascertained; nor was the date of his arrival in America found.

The earliest record found of his name is in Salem—a deed from Daniel Southwick of Salem to John Blethen of Lynn, Sept. 28, 1659.

The first Friends who came to America arrived in Boston in 1656. Taking this date in connection with the date of the above named deed, it appears that John Blethen was among the early, if not the earliest, arrivals of Quakers in America, at a time when they were considered heretics and were treated by the Puritan authorities after the orthodox methods of those days.

It is related that in 1656 several Friends arrived at

Boston, and were the first who came to America. To prevent the spreading of what was called their "herectical doctrines," they were ordered to leave the colony. A part of them went to Oyster Bay, L. I. From there they proceeded to Jamaica, Gravesend, and some other places, boldly preaching the truths of the Gospel. Notwithstanding the persecution to which they were subjected, many of the inhabitants embraced their views and held their meetings in the fields and woods.

In 1657, Gerard Roberts, a Friend and merchant, sent a vessel to America in which came ten Friends, among whom were Robert Hodgson, Mary Whitherhead and Dorothy Waugh. They landed in six months at New Amsterdam, and were the first Friends who visited this part of the country.

The women were arrested for preaching in the streets, and confined separate in wet, miry dungeons for more than a week. They were then taken out, their hands tied behind them, led to a vessel and sent to Rhode Island.

Rob't Hodgson went to Hempstead, Long Island, and held a meeting there. He was arrested, his bible and papers were taken from him, he was tied to a cart and dragged through the woods to New Amsterdam, a distance of twenty miles, and thrust into a dungeon. He was sentenced to work with a negro two years at a wheelbarrow, or pay a fine of 600 guilders. He was chained to a barrow, and suffered much cruelty from those in whose charge he was. He was finally released with several Friends from New England, through the intercession of Governor Stuyvesant's sister.

In 1666 John Burnyeat arrived at New York, and "spent some time there with Friends in going through their meetings." Again in 1671 he visited New York, and attended the Half-Years Meeting at Oyster Bay. This appears to be the first established meeting for discipline in the State of New York.

George Fox arrived in Maryland in 1672, and after attending some meetings there proceeded Northward through Delaware and New Jersey, and crossing over to Gravesend passed on to Flushing and thence to the Half-Years Meeting at Oyster Bay.

The earliest records of Quarterly Meetings is in 1673, one being held that year in Flushing. In 1680 a Quarterly Meeting was held at Jericho, and one at Gravesend, and in 1687 another at Matinecock. Whether these were independent of each other, or whether they constituted one meeting held occasionally at each place, the records do not show. From some circumstances it is supposed there was but one meeting, and that the minutes bear date at each of these places named, according as they were held at either of them.

In 1684 a Monthly Meeting was held in New York. Meetings for worship were held at all the places named; and at the same time, or a few years later, at West Chester, Newtown, Bethpage, Jerusalem and some other places.

These meetings were subordinate to New England Yearly Meetings until 1695, when they were set off by that Meeting, and, with other meetings in the State of New York, formed a new one under the name of New York Yearly Meeting—held at Flushing until 1777, and then at Westbury until 1794, in which year it was removed to the City of New York.

John Blethen did not wholly escape the penalties paid by heretics in those days. Neither were the Friends always friendly to each other.

In the Annals of Salem it speaks of John Blevin (pps.

227, 235 and 237), June 26th, 1668, Josiah and Daniel Southwick & John Blevin refused to pay a fine of £1 apiece and were ordered to be whipped. 1668, Nov. 24, some of the Friends were fined £8.10. Saml Shabbock, John Blevin Josiah Southwick and Joshua Buffum were committed to prison one month for not paying their fines. 1669, June 29th, some of the Friends were fined £9.10. John Blevin and Robert Gray were imprisoned for not giving security.

It may be noticed that it was "Blevin" not "Blethen" who was punished. They did not seem to be very particular about their spelling.

In the records of Deeds in Salem is one from John Burnell to John Blethen. In the acknowledgement the name was written "Bliven." In the deed from Bridget Oliver it was "John Blevin," and when John's widow sold the property she signed her name "Jane Blevin alias Blethen." In another deed the signatures are Jane Blevin, John Blethin, Mary Bleven. In a deposition John Foster and Jos. Boyce deposed that they knew for forty years a lot as the Blevin lot. When it was sold to Sam West it was signed as the above "Blevin."

Reference has been made to John's widow. The record is that he married Jane Marks May 10th, 1672, at Salem, Mass. You will notice that in his will (herein copied) his wife is made joint executor with their son John; and following the will is the interesting inventory of the estate. The list of children mentioned in the will gives us the starting point from the deceased, John, whom we will herein call John First.

[°] A deed is on record dated May, 1716, from the son, John² and wife Mary, and her son Wm. Robinson, all of Swansey, Bristol Co., Mass.

We have the date of the birth of John's daughter, Eliza-

beth, reported as 1680. This is probably a mistake, as in 1704, at the time of making his will, his daughters were not of adult age. It will be seen that no descendants of the daughters of John' are herein given.

C. P. BLETHEN'S RESEARCH IN ENGLAND AND WALES.

C. P. Blethen, Esq., of San Francisco, Cal., and also residing in Shanghai, China, wrote to London, England, on April 21, 1876, for information as to Blethen pedigree anterior to 1580.

John Pook & Co., 4 Lime Street Square, London, undertakes to inform C. P. Blethen. Warns him that it will be expensive. First charge £10, 15s. 6d. He says: "Not many, if any, Blethens now living in Wales. Pook warned "Searcher" Oliver to keep within £50 limit unless expressly requested to go further.

Consulted manuscripts in British Museum, including four large folio volumes belonging to a private family, who loaned it to the Museum. It would cost 190 pounds to put in genealogical tabular form. He would not vouch for the truth of one-tenth of such information. The only way to get at the truth is by "the collection of wills, ancient deeds, parish registers, etc." The expense would be very extensive. He furnished genealogies at various detached times, as follows:

Will of Lewys Blethin of Carlion, Co. Monmouth, Gent, dated Sept. 29, 1542, proved at London, 16th Nov., 1542.

Will of William Blethin, Bishop of Landaff, dated Oct. 1, 1590, proved at London 21st May, 1591. Pook consulted Sir Thomas Phillips Glamorganshire Pedigrees, which included the Herald's Visitations of Wales by Sir Isaac Heard. Edited by Sir Thomas Phillips in 1845.

Reference is also made to York's Royal Tribes of Wales, "Dictionary of National Biography," under Morgan, etc.; "History of the Princes of South Wales," by Rev. G. T. O. Bridgeman; "History of Glamorganshire," by Nicholas; "History of Wales," etc.

Annexed is the genealogy of the descendants of Morgan Mwyn Vaw (Morgan, the Great, the Glorious), from York's Royal Tribes of Wales and History of Glamorganshire, by Nicholas, as copied by Bliven, Esq.; also the genealogies, as copied by the British Searchers, from the manuscript in the British Museum; and from the "Herald's Visitations" of Wales, by Sir Isaac Heard, compiled and edited by Sir Phillips Bart.

See letters of John Pook & Co.; also a brief genealogy that rivals the Hebrew, as, like the Hebrew, it takes the ancestry back from generation to generation to God.

Mr. Bliven refers us to the "History of Wales," from earliest times to final incorporation with England, by B. B. Woodward, B. A.—Virtue & Co., London, Publishers; wherein we are told that "Bleiddan" (or Lupus), Bishop of Troyes, was sent on Apostolic errand. Bleiddan accompanied St. Gemmanus on his apostolic visit to Britain.

He, Bliven, also says the Blethen coat-of-arms was a "shield, sable color (black), chevron argent white, star gold, three spear heads," with motto:

"Tiens Le Droit"--- "MAINTAIN THE RIGHT."

SEARCHER'S REPORT.

I send you herewith the Genealogy of Bledhin or Blethyn ap Cynfyn or Rynfyn as entered in a manuscript in the British Museum. Also four generations anterior to the Jestin, who begins the pedigree formerly sent and several additions to it, such as children of said Jestin, his wives and some of the wives of his descendants which were not given in the pedigree extracted from Sir Thomas Phillips Glamorganshire Pedigrees and which are entered in a manuscript work in four large folio volumes belonging to a private family who has lent it to the custody of the Records Office for the benefit of Antiquarians, Genealogists and the Public in general.

I must inform you that there are 51 pages folio covered with the descendants of Bledhin or Blethyn—or otherwise as I find his name differently spelt almost at every page—ap *Cynfyn* ap Gwerstan Li, together with a great deal of other information scattered all over the four books, but as it would take not less than three months to collect the whole as it stands (not put in one single Genealogical Tabular form) I could not undertake the work for less than about 120 pounds and if the whole or as much of it as can be should have to be put in Genealogical Tabular Form, the price would be 190 pounds or thereabout, according to the time it would take. But as the descendants of the said Blethyn ap Cynfyn are not immediately connected with the Blethyns whose Pedigree I sent you; being only Cousins in First, 2nd, 3rd and 4th degree I feel not justified in involving your client to such an expense without his consent and without his being informed at the same time that I would not even vouch for the tenth of all such information as might be gathered therefrom. The only way to ascertain the truth in these matters is by the collection of wills, Ancient Deeds, Parish Registers, etc., but the dates are so remote that even then such searching would no doubt prove very unsatisfactory as to completeness, specially as the expenses would be then very extensive.

If, therefore, your client will nevertheless go on with the matter I shall be happy to render you all the assistance in my power and beg to remain,

Monmouth, Gent; will dated 29th Sept. 1542, proved at London 16 Novembre 1542, directs his body robe buried in Parish Church of St. Cadoks in said town of Carlyon; wills to the Cathedral Church of Llandaff 3/4; he gave nearly all his property in Monmouthshire and Glamorganshire to his wife and the heirs lawfully begotten betwixt him and her the said Jane &c. (but he makes no mention of any of his children's names, if any). Mentions his Unkell (uncle) John William Blethen.

The will names testator's wife, Jane, executrix, in conjunction with her brother, William Morgan. 1591

WILLIAM BLETHIN, Bishop of Llandaff, will dated 1st Oct. 1590, proved at London 21st May 1591—Anne "my wief"—wills his body robe burned in the Parish Church (in the Chauncell) of Matharn.

This branch of the Herberts became extinct in the line male in 1748 on the death of the 3rd Earl and Marquess Wm. Herbert, when Powis Castle passed by marriage of his niece Barbaria to Henry Arthur Herbert 1st Baron Herbert of Chesbury descended from a common ancestor, who was now created Baron Earl of Powis.

His son Geo. Edward dying without issue Powis Castle passed (A D 1804) with his sister and heiress Henrietta Antoria to her husband, Edward Clive, first Baron Clive, who was created Baron And Earl of Powis in whose descendents it has ever invested.

The proceedings in the Star Chamber respecting the murderous assault upon Geo ap Morgan, riotous affair committed by Walter Herbert and William Herbert in the town of Newport in Monmouthshire on Sunday, the 23rd of February 1533, p. 61 Morgan Family by G. B. Morgan.

BY COL. ALDEN J. BLETHEN.

Col. Alden J. Blethen quotes a remark of his grand-father:

"I, Joseph Blethen, am now in my 69th year, and my nerves are in tremulous condition," and A. J. adds:

My grandfather lived to be nearly 86 years of age. Until his 50th year he was an infidel in his religious belief or rather want of a belief. Until he was 70 years of age he was in a doubtful condition—neither an advocate of any religion, nor yet a believer in any of the 'isms of the day—but from his 71st year until the day of his death, about fifteen years as nearly as I can recall (and I remember my grandfather when I was but eight years of age, or as early as 1854,) he was a Quaker, thoroughly imbued with all their peculiarities in their characteristics, even to wearing a broad-brimmed hat and the use of the Scriptural language, which so eminently characterize the Quakers of New England. I give a few abstracts from his feelings in 1848, before he had passed out of the atheistic condition of his early manhood.

Alden J. Blethen (grandson to Joseph Blethen and son of Alden above named), who caused this record to be here transcribed. Grandfather Joseph Blethen says:

'Genealogy of my Family on my Maternal Side.

'Permit me to say I have no record of my father's family except his own age.

'If there be no error, and I believe there to be none— Sir William Thomson, knight and baron, of the City of London, was the father of Samuel Thompson, who came over to America and settled in the town of Ipswich, in the State of Massachusetts, about the year 1715.

'Samuel's family consisted of William, Samuel and Joseph. Samuel died when a mere boy. Joseph was my grandfather, as will be observed by this record.—Joseph Blethen.

'The great fortune, consisting of many millions of dollars, for which we have so long contended, was left by Sir William Thomson, my great great grandfather, that is, my grandfather's grandfather.

'I have written my name that it may be seen when I am not to be seen. It is now evening, and I am writing by candle light, and that is why I write so feebly, my eyesight being poorer than usual by reason of a bad cold.—Joseph Blethen.

'The plate (that is the silver cup) was sent to America by Sir William Thomson to his son Samuel, and by him given to his sons, William and Joseph, as testimonial of their right in heirship to this fortune.

To William was given the cup having two handles, with the name of Samuel inscribed upon it.

To Joseph was given the cup without a handle. The form of the latter was of a wine glass; its weight was \$10 and three-fourths in value. A bust was also given to Joseph Thompson, and a coat was given to William.

'Shame on them that they neglected to get this great fortune.'

Thorndike, Saturday Eve, May 19, 1849.

Mr. Blethen, I have this moment received your letter, and deeply regret that I am under the necessity of informing you that probably from information by our Agent, who went to London last season, we have been defrauded of our right to a large fortune. However, your information of a fortune for the Blethen heirs is correct so far as regards the descendants of my father whose given name was Job. He had a brother John, from whom I suppose you descended. The reason why no other Blethen family would have been claimants is this: The fortune comes not by the Blethen blood. My mother was granddaughter to Samuel Thomson, who came from England about the first of the 17 Century. The letter and cups of which you make mention with the family Coat of Arms were sent to my Great Grandfather, Samuel Thomson, but my predecessors, because of misfortunes that befell many at that time who went out to England and other parts in Europe, to obtain property durst not venture there on such business. Our agent has returned; he gives us no encouragement of obtaining the fortune. Dear Sir, I am in my 70th year, but should be extremely obliged to you, if you travel into this part of the Country, that you will call on me. In sincerity, I bid you farewell.

P. S. I shall mail this at Unity in the morning, that you may hear sooner than from this place, because tis only weekly, being sent Sunday morning. Dear Sir. As regards this fortune it has for many years been supposed lost to the Heirs in America because it was not called for at the death of the only heir in England. This impression was entertained because it was stated in the letter to my Gt. Grandfather in case of neglect it would be put into the Exchequer.

But Sir I heard of the advertisement of the property, and having seen one of the silver cups 44 years ago, the weight of which was 10 and 3-4 dollars, bearing the family coat of Arms. I set about the inquiry to ascertain its availability. If ultimately it turns out disappointment my ability for benevolence will never have arrived.

My tradition of the Blethen Genealogy is, that my Gt. Grandfather came from England to America not far from the first of the 17 century, he had three sons, Nathaniel, Samuel and John, the latter was my grandfather, he had four sons, James, (this one lost at sea near Portland) John, Job and Increase, also 4 daughters (1 of whom lived to be 106 years and 25 days old. She died in Unity, by the name of Chase. I was at her funeral, my Gt. Grandfather Thomson had six sons and two or three daughters. Joseph was my Grandfather he had 18 children, the mother of this host was only one woman. More than 100 names were sent to England. Go see Simon Day or Jesse, it may give you Great Satisfaction You may find in the first Volume of Modern Europe in 66 of the Eleventh, mention made of Blethin Prince of Wales. His name is but once found. You may see that I in the last syllable is instead of E. I presume it was the original spelling of the name. You see the tremulous condition of my nerves. I really should be greatly gratified, were I with you. Come Sir, take a tour this way, don't stop to think too much.

"Some Religious Ideas."

"I hope that the great fortune, to which I have referred, will be recovered, and thereby benefit posterity by helping to wipe off superstition, hypocrisy and bigotry, that people may believe for themselves-pinning their faith on no man's sleeve who will assert that the Lord ordered the Israelites, with Josh at their head, to murder thirty one kings and destroy their kingdom and take their property to themselves, as the story is told. This Josh, not only stopped the sun, but did many other remarkable things, as the stories are told, quite as impossible. But they were sanctioned by the hypocritical cant of inspiration, and hence had their effect. At the same time would any one have the daring impudence to assert that the same Lord that sets one man to butcher and rob his fellow creatures should be worshiped and adored. [This I do not deem correct, for the Lord is doing always good to those who come for good motives .--- W. W. B.] I believe in an Almighty Power that brought everything into existencebut further than this no one ever did or ever will know.

My belief decidedly is that death produces an eternal sleep.—Joseph Blethen.

The reasons that I give for this belief is, that death is the most powerful destroyer of the Physical faculties, and no less so to the mental, which is known to us.

*All are aware that some mere accident has, in numerous instances, wholly destroyed the mind which is that part of man believed to be the immortal and never dying part of man—the leading faculties of which are memory, judgment and imagination. Let anyone be deprived of memory and all is gone. The whole cause that brought man into this belief—that the human species possess supernatural part, was produced and brought about by the dread of death. So says common sense.

Perhaps I should say in my explanation of the foregoing, that Sir William Thompson, Knight and Baron of the City of London, to whom my grandfather alludes, left his fortune without heirship—the same having been in the hands of the government of Great Britain since the death of Sir William—his heirs having all emigrated to America.

From the time my grandfather was forty years of age, or about 1830 down to 1850, he never gave up the hope of obtaining this fortune, to which he was direct heir, which will appear from the record herein contained.

In fact, in 1850, my grandfather went so far as to equip a special agent, and furnish him with a thousand dollars in money, to go to the Court of St. James, and to present the claim of the heirs of Sir William Thompson for this fortune, which was then believed to amount, in the aggregate, to something more than ten millions of dollars.

With this explanation, the various allusions made by my grandfather to "this fortune" will be understood.

ALDEN J. BLETHEN,

Son of Alden Blethen, and grandson to Joseph Blethen, both of whom are named in this record.

David W. Phipps remembers seeing his great uncle, Joseph Blethen, in Knox, Me. Knox adjoins Thorndike, where Joseph lived. In 1841 Mrs. Wealthy (Warren) Brock was fatally ill with consumption and Joseph frequently came to the house with delicacies and medicines to alleviate the sufferings of his niece, the daughter of his sister Elizabeth. David was only four years old; but he still retains the impression of his great uncle as a tall, slim man in long, gray coat and broad-brimmed hat; and of his "thee" and "thou" after the mode of expression in the Bible; the same way that Grandma Elizabeth Warren spoke; and their pronunciation of "put"—they sounded the letter "u" like "u" in "hut."

In later years when David's mother (then married the second time), Mrs. Phebe P. Bucklin, lived in Belfast, Maine, her uncle Joseph made occasional visits, on his trips to town, and David remembers about "Uncle Joseph's" speaking of his farm being a part of a land grant to Gen. Knox, after the Revolutionary War. Joseph. said he went to work on the land to get from it the means of paying for it; but before he had accomplished the task he came to the conclusion that it would have been easier done by working out than by trying to extract the cash from the wild woodland.

Joseph at one time was a representative of Maine in the General Court (Legislature) of Massachusetts. It will be remembered that until 1820 Maine was a part of Massachusetts territory.

David remembers that on one of Joseph's visits to the Bucklin home, he told of his re-conversion from materialism to a belief in life after death. This was after "Spirit rappings" were taking place, and Joseph had had such convincing manifestations of the presence of relatives who had left the physical body that he could no longer deny the fact or possibility of life after the death of the physical body, and he was no longer held by the French materialistic philosophy of those times." At the time that Joseph 5 was trying to get the estate of Sir William Thompson inquiries were made by relatives regarding the Thompson genealogy. In his replies he furnished the following:

David Warren Phipps says:

"Regarding Job Fourth's daughter, Elizabeth, or Eliza, as usually called (my grandmother), she married Rev. Charles Warren, son of Henry Warren of the old colonial stock. Henry (my great grandfather) and his widow lived, died and were buried in Belfast, Maine. I don't know when they came from the vicinity of the Kennebec River. Grandfather Charles Warren was a farmer and cobbler and a Free-Will Baptist preacher, ordained at Thorndike Oct. 4, 1821. He bought a farm in Plymouth, Maine, and there they lived, raised their family and died. They had five children: Christiana, Wealthy, Phebe Philbrick, Mary and Sylvanus. They have all dropped the physical body.

Christiana married Harvey Brock, and Wealthy married James Brock. Both families moved from Plymouth, Maine; Harvey to Searsport and his brother James to Knox and then to Belfast, Maine.

Aunt Wealthy had four children: Almira (7th), Eliza (7th), Charles (7th), and Susan (7th). Almira and Susan lived to grow up and get married, and Almira (Fisher) had one daughter, Wealthy Fisher, who married Herbert Wiley; Susan married lieutenant Leroy Scott of Belfast, who was killed at the Battle of Gettysburg. The following is a clipping taken from a newspaper in Reading, Mass., dated Saturday, April 29, 1899:

"Sudden Death of Dr. Blethen."

"Dr. Alonzo Cary Blethen was taken ill at 11 p. m. Thursday and died at 4 Friday morning. The attending physician ascribes neuralgia of the heart as the cause of death. The doctor had been warned by physicians to avoid all excitement several years ago, and while he was not told that he had a heart difficulty, such was probably the case. He was at work all the afternoon preceding his death on property owned by him on Federal Street. His age was 71 years, 8 months, 27 days.

Dr. Blethen was born in Dover, Maine, near Bangor. He learned the profession of dentistry of old Dr. Dudley, the most thorough and advanced dentist of his time. Dr. Blethen started in business for himself in Stoneham, and met with success that would have satisfied a less ambitious man. Convinced that this field would not give him much more than a living, he established himself in Lynn in 1850, where he was very successful. He had the reputation among dealers in dentists' supplies of doing the largest business in his line in Essex county.

Deceased came to Reading in 1886. He has practiced some at his profession here, but never made any special effort to get business. He was a successful man, his extreme affability and pleasantness contributing to his material prosperity. Familiarity with all matters of public import made him an interesting conversationalist. His neighbors bear testimony as to his worth as an individual and a citizen.

Dr. Blethen was a member of the Masonic fraternity. For seven years he was High Priest of the Lynn Chapter.

He is survived by a sorrowing widow.

The funeral services will be held from the late home on Monday."

In 1841 John Nelson Blethen removed to Lowell, Mass., where he secured employment as second overseer in the spinning department of the Middlesex Corporation Woolen Mills, under the agency of James Cook.

On Nov. 20, 1843, he married Mary Jane Cobb of Windham, Maine.

In 1845 he removed to Winooski, Vt., and engaged with the woolen mills in that town as overseer in the spinning department, where he was employed for fourteen years.

In 1859, owing to financial difficulty of the firm, he was obliged to secure other business, and he thought the time had come for him to start in for himself. He went into the axle business with another party, putting all that he had in it, and more too, for an entire new equipment.

On the very night of the day in which he was well started and ready for business, fire destroyed the building and all the machinery, leaving him many dollars worse off than nothing, as he had no insurance. He was planning for insurance the next day, but alas! was one day too late.

His partner immediately went into bankruptcy, but John Nelson's honesty and pride would not allow him to do it, and as far as I have been able to learn (although it was before I was born), he paid one hundred cents on a dollar out of his hard earnings later on. I believe in honesty myself, but in this case I think he would have been justified in taking the same course his partner did, as I believe a man's first duty is always to his family.

He then moved to Burlington, Vt., and secured employment with the Barnes, Davis Lumber Co., where he had full charge of the shipping department, and remained in that business until his death, July 28, 1881. So writes Cora Blethen, daughter of John Nelson 6th.

On August 14, 1862, he was appointed captain of Company G., First Regiment of Cavalry Maine Volunteers, by Gov. Israel Washburn Jr. of Maine. On Sept. 4, 1862, he was detailed with Company G. as Gen. Reno's bodyguard, and was with Gen. Reno at the time he was killed. He then reported to Gen. Burnside, remaining with him until about Nov. 20, 1862. Children: Harold T. Helen Bernice Herbert W., Jr. Alden Joseph Blethen, Jr., born April 16, 1870, Farmington, Maine. Attended Miss Fuller's school for children in Portland, Me., 1877 to 1880. Attended St. Mary's School for Boys, Kansas City, 1880 to 1883, and Spaulding Commercial College. Kansas City, 1884.

Entered Minneapolis Academy, Minneapolis, Minnesota, January, 1885. Entered preparatory department University of Minnesota September, 1886, and matriculated September, 1887, in the University proper for the classical course, graduating June, 1891. Member of Delta Kappa Epsilon Fraternity.

After a short experience in commercial lines in Minneapolis, entered journalism in fall of 1893 in that same city, and continued in that occupation until 1896. Then moved to Seattle to join Colonel A. J. Blethen in The Seattle Times. Became Managing Editor, then Associate Editor, and in January, 1909, became Vice President and Business Manager.

Married June 21, 1899, Genevieve, daughter of Mr. and Mrs. David Foster Swadley; born in Yates City, Illinois.

One child, Alden Aldrich Elethen, born March 9, 1908. Died March 21, 1908.

While Associate Editor on The Times wrote short stories which appeared in standard magazines, the libretto of two comic operas and one play, which were produced on the American stage. Clarance Brettun Blethen (always known as C. B. Blethen) was born in Portland, Maine, February 1, 1879, He attended the graded and high schools in Minneapolis and took special courses in the University of Washington and the University of Chicago, finishing this portion of his education in 1900. He was taught as a boy to understand the mechanical principles of newspaper work, and by close attention to his father's papers was well grounded in journalism before he left college.

He became News Editor of The Seattle Times in June, 1900. He was made Managing Editor a few years later, and has occupied this position ever since. He has worked in every capacity known to the editorial and news departments of a newspaper and has invented a long series of mechanical processes having to do with printing, photographing and photo-engraving. He has also devised an entirely new system of management as applied to the editorial and news departments of The Times.

C. B. Blethen was first married in 1901 to Frances A. Hall of Seattle, who died July 5th, 1908, leaving two splendid sons, Frances Alden (1904), and Clarance Brettun Blethen 2nd (1906).

He was married again in 1909 to Rachael Florence Kingsley. His third son, Alden Joseph Blethen 3rd, was born in 1910.
