NOTE. — This little work makes no pretention to be a complete genealogy of the BURBANK FAMILY from its settlement in America to the present time; it preserves such records and incidents relating to the family as could be gathered from Town and Parish Registers and by a considerable correspondence. It is to be hoped that some one will in future supply the deficiencies, and publish a complete genealogy and history of this distinguished family. No doubt errors will be discovered, but the compiler has carefully transcribed originals placed in his hands. A few blanks are inserted for corrections and addenda.

THE SURNAME. I have carefully examined the new "Doomsday Book" and can find the surname "Burbank" but once in a list of some ten thousand names of land-owners in Great Brittain. But I find the name "Bowerbank" in several counties. The name was spelled "Borebancke" in the early New England records. The name "Bowbank" is also found in English books. An old lady connected with the Long Island branch believes her ancestors spelled their names "Burbancke." Almost every surname found in New England has been changed in orthography, and I have little doubt that the original of this surname was "Bowerbank."

COAT OF ARMS. I can find no mention of a coat of Arms in "Burk's General Armory." Walford in his "County Families" does not mention the family. The tradition that they were of German derivation may be true, and if so, a coat of arms may have been granted the family before their settlement in England.

# BURBANK FAMILY RECORDS.

- **1 John Burbank** was made freeman in Rowley, Mass., 13 May 1640. In his will of 5 April 1681, he mentions wife *Jimima* and children *John, Caleb and Lydia*. This John is supposed to be the ancestor of all of the name in New England.
- 2 Joseph Burbank came over in the ship "Abigail" from London, England, in 1635, aged 24, but "it is not known (says Savage) where he sat down." When at the Custom House his name was spelled "*Borebancke*."
- 3 Caleb Burbank, supposed to be son of John (1) was of Rowley, Mass., in 1691. Had children John and Lydia: perhaps others. It will be seen that "*Caleb*" as well as other early family names have been continued in the family.
- 4 John Burbank, supposed to be son of John (1) was of Haverhill, Mass., and married 15 Oct. 1663, Susanna, daughter of Nathaniel Merrill. He removed to Suffield in 1680 with several children. Wife died in Suffield in 1690; and though he had second and third wives, no more children.
- 5 Lydia Burbank, daughter of Caleb (3) married Abram Foster in 1655.
- 6 John Burbank, son of John (4) married Mary Granger 21 Dec. 1699: died in 1739. See "Early Puritan Settlers of Connecticut." John's children as follows:
- i. John, son of John (6) was born 18 Feb. 1701; married Rachel Austin in 1732 and had issue seven children as follows:

- i. HORACE H., Esq., born in Limerick, Oct. 27, 1837; married Elizabeth Thompson of Kennebunk, and resides in Saco, Me. He graduated at Bowdoin College. He has been County Attorney for York County, Me., and Register of Probate for same county. Now in practice of Law with John S. Derby, in Saco. Three children.
- ii. ALBION, born in Limerick, Me., Dec. 25, 1839; married Miss Olive E. Thompson. Gratuated at Bowdoin College. Was admitted to the Bar. Teacher for many years in High School at Exeter, N. H.

PORTER S., sixth son of Samuel (iv) was born in Newfield, Me., March 13, 1810; married July 16, 1837, Miriam Blazo Burbank, (she was born in Newfield, Me., Jan. 22, 1812) of a kindred stock, and had issue five children, of whom hereafter. He graduated at Dartmouth College in 1837. Taught in Stafford Academy N. H., 3 years. Ordained F. W. Baptist minister, and has preached since 1840. Has been corresponding Editor of the "Morning Star" 30 years. Clerk N. Hampshire Yearly Meeting 6 years. President F. W. B. Educational Society several years. Trustee of New Hampton Seminary, N. H., Maine State Seminery at Lewiston and Bates College. Now resident in Parsonsfield, Me. Children:

# BURBANKS OF KENNEBUNK MAINE.

- 10 John Burbank, was born in Bradford, Mass. Was one of the first settlers in Arundel, (now Kennebunk), Me. Millman, by occupation. Engaged in coasting trade and lost a large schooner on his first trip to Halifax, in 1750. Was 2d Lieut. in the expedition to Louisburg, in 1745. His wife's name does not appear. His children as far as known to the author, as follows:
  - i. John, son of John (10), was "master-at-arms," under Paul Jones in the "Bon Homme Richard" and the "Serapis," and while the latter was sinking he released the prisoners and was censured by Jones; this was during the encounter with

the "Countess of Scarborough." He was stationed at Portsmouth, in the company of Capt. Eliphalet Davis, in 1776. Was captured in the brig "Charming Polly," and sent to England on board the "Dalton," in 1777. He subsequently settled in Lyman, Me., and was living there in 1837.

- ii. Benjamin, son of John (10), settled in Brownfield, Me. He married and had a numerous family, as follows:
  - I Dea. Asa, son of Benjamin (ii), married Eunice Hutchins, 1751; 2ndly Esther Emery, 1767; 3dly Hannah Foster. Was Selectman in Arundel, (Kennebunk), in 1780. Died in Feb. 1824, aged 90. He was in the expedition to Louisburgh, or his uncle by the same name. Children as follows:

He was identified with every enterprise which contributed to the growth of the city of St. Paul. A man of integrity and worth.
- 11 ABEL, son of Samuel (i), born in Fitchburgh, Mass. Died in Proctorsville, Vt., May 21, 1877. Merchant. Children as follows:

# BURBANCKS OF STATEN ISLAND, NEW YORK.

#### (GERMAN BRANCH.)

- 15 Abraham Burbanck, is said to have come from Netherlands with two brothers and two sisters in the ship "Caledonia"; the vessel was partly wrecked on the passage and one sister was lost. They landed in New York early in the 18th century, and Abraham settled on Staten Island; the other brothers proceeded in other directions. This branch claim to be of a French-German stock, and there is preserved in the family a tall clock, writing-desk, and secretary-bureau, handed down from the ancestor, said to be quite two hundred years old. Is it possible that *John* and *Joseph* so early in New England, (see other branches in this book) were of the same stock? It will be seen that *Joseph's* name at the Custom House was spelled almost identical with this ancestor, viz: "Borebancke." I have no mention of Abrahams wife. Children as follows:
  - i. Abraham, son of Abraham (15), was born November 20, 1745, and died May 12, 1823. Children as follows:

- 3 ISAAC, son of Abraham (i), had three children as follows: 1 Mary A., married Vincent Bodie; 2 Edward, Sanitary Police, New York, and 3 Sarah J.
- 4 JOHN, son of Abraham (i), had issue as follows: 1 Ann, 2 Mary, 3 Daniel, 4 Henry, 5 John, and 6 Catherine.

NOTE. — There are two Edward Burbancks and two Samuel Burbancks (father and son), living in Staten Island. Also, numerous descendants of the first Abraham on the female side. The family is the largest on the Island; those on the North side are said to be "too numerous to mention."
