INTRODUCTION

The earliest spelling of the name of our first known ancestor was Booth, as appears on the original land grant issued to Daniel Booth. In his will, he spells his name Booth; his name is spelled Booth in his Revolutionary Service Voucher; his son Joseph's name is spelled Booth on his Revolutionary Service Voucher; however, it is most interesting to note that Joseph Boothe, in his will, spells his name with an "e" and in the will of every generation down to the author, it has been spelled with an "e." It is also necessary to mention that close relatives in North Carolina spell their names without the "e." Therefore, it is reasonable to conclude that either spelling is correct.

I have not included one of the many Boothe Coat of Arms in this genealogy because a coat of arms belongs only to the person to whom it was granted and to his descendants, not to every person bearing the same name. Therefore, since Daniel Boothe is our earliest known ancester and since it can not be proven that he was entitled to bear a coat of arms, none of us have the right to display a Boothe Coat of Arms. If more information is desired on this subject, I suggest that you consult the D.A.R. Magazine (September, 1957), p. 1051, or the section on Heraldry in a good encyclopedia.

No attempt has been made to trace the descendants of all the Boothes in each generation. However, when I had such information, I included it or gave references to the sources from which it could be found.

I wish to express my sincere appreciation to all who have helped to make this genealogy possible: Mrs. Percy Caldwell (Marielou Roach) Fair, Mansfield, Louisiana, for her invaluable assistance; Mr. Guy Cswald Booth, Cary, N.C., for his helpfulness; Mrs. Lillie (Boothe) Nesbitt, for her work years ago on the Boothe family; and my parents Rocs and Lucile (Bonnet) Boothe, for their inspiring guidance.

DANIEL BOOTHE

DANIEL BOOTHE, born in Virginia, c. 1719, was married in Virginia 3 c. 17464, to Priscilla, who was born c. 17303.

The following land grant, number 28, was issued to Daniel Boothe on 6/28/1762. This is an accurate copy from a photostatic copy of the original on file in the office of the Secretary of State of North Carolina:

No. 28. Daniel Booth Two hundred and eighty two acres of land in Orange County on Barbees Creek Beginning at a hickory. Booth line No. 65 ch: to a pine thence West 30 ch: to a pine on Barbees line thence south along his line up the Cr. 211/2 ch; to a white oak Saplin thence along his line West 20 chains to a pine thence So 431/2 chains to a pine thence ET across Cr to the first Station dated 28th day of June 1762.

Daniel Boothe made his will in Orange County on 3/2/1801 and it was proved in open court during the November Term, 1801; therefore, Daniel's death occurred between 3/2/1801 and 11/--/1801. Mrs. Priscilla Boothe died c. 1805⁸. An accurate copy from a photostatic copy of Daniel's will recorded in Will Book D. page 78. Orange County, N.C., follows:

IN THE NAME OF GOD AMIN:

I Daniel Booth of the County of Orange and State of North Carolina, being a weke and declining state of helth but of sound mind and perfect memory thanks be to my gracious preserver for the same, and Calling to mind the uncertainty of all sublinary things and that it is appointed for all men to die, and in order to preserve Love and harmony among my Family do dispose of the worldly property—that God hath in his abundant mercy has blessed me with in the way and manner hereafter mentioned ————

First, Bequeathing maximmortal Soul to God who gave it hopeing for a free pardain for my sins, with Exceptance thro the alone merits of Jesus Christ the glorious Redeemer of fallen man, my Body I give up to be Buryed in a decent maner in the Bowels of its mother Earth there to be till the glorious morning of the Resurcetion thence to be raised by the mity power of God Reunited to my immortal Spirit.

IMPRIMIS

Item I lend unto my beloved wife Prissily Booth during her life or Woddowhood my negro woman Inde and two fether Bed and Furniture and all my Houshould and Kichin Furniture and the plantation and tools where I now live I also lend to my sd wife Two work Horses Four Cows and Calves four sows and pigs fifteen fat Hoggs, Forty Earrels of Corn and Fodder Equivalent.

Item I give to my son Gray Booth Twenty Shillings -

Item I give to my son John Booth the Plantation where he now lives known by the name of hutsons plantation -

Item I give to my son Mark Booth one Hundred and fifty acres of Land to be taken of the west side of mg Mountain Tract -

Item I give to my son Tapley Booth one hundred and seventy five acres adjoining his Brother Marks land.

Item I give to my son Joseph Booth - one hundred and seventy five acres of land adjoining his Brother Tapley's Land -

Item I give to my son Daniel Booth Tow Hundred and forty-five acres of Land known by the name of "Casselburrys" place I also allow him the sJ-Daniel Booth to pay to his Brother John Booth twenty pounds within Two years after my decease.

Item I give to my son Solomen Booth the one half of my home plantation including my dwelling house -

Item I give to my son Alphred Booth the other half of my home Tract of land -

Item I desire that my Lot at the University containing Two acres may be sold and the money arising therefrom is for to pay for the Education of my Children.

Item I give to my Daters namely Ruthy, Polly, Betty, Silvey, Ritty, and

Patty. I leve all my stock that is not lent to my wife I desire it may be sold and the money that Remains after paying my Just debts is to be Equaly divided among my aforesaid dix Dauters—and all the property I lent to my wife Except the Land is to be sold at her deth or marriage and the money Equaly divided among my six Dawters.

And Lastly I reminate and appoint my wife Prisilly Booth my son John Booth and John Moore to be Executors of this my last will and Testament and I do hereby Vest them with full and Ampel powers for that purpose Revoking and disanuling all other will or wills heretofore by me made Eighther in work or Riteing Ratifying and Confessing this to be my last will and Testament in witness whereof I have hereunto set my hand and affixed my seale this second day of March 1801.

JOSEPH BOOTHE

JOSEPH BOOTHE ^{II}, son of ¹² Daniel and Priscilla Boothe, was born in Virginia ¹³, in 1750, and was married to Sarah c. 1780, possibly in Orange County, North Carolina. Sarah was born c. 1753, 17.

The following Colonial Service 18 of Joseph Boothe is of interest and value: These are to certify that Joseph Booth Came before me, took the oaths of Allegiance & acknowledged him Self to be duly Enlisted in the Company of Artillery Commanded by Coll James Moore, & that he had received the Bounty allow'd on the Service In which he is Enlisted as Gunner.

Joseph Boothe made his will in Orange County on 9/7/1824 and it was probated during August 1825; therefore, Joseph died between 9/7/1824 and 8/--/1825. Sarah Boothe died after 9/7/1824, Orange County, for she was living when Poseph made his will. An accurate copy from a photostatic copy of Joseph's will recorded in Will Book E, page 86, Orange County, North Carolina, follows:

In the name of God Amen. September the 7th day, one thousand Eight hundred and twenty four.

I Joseph Boothe Senr., of Orange County of State of North Carolina considering the uncertainty of this mortal life, though being weak in body, yet of perfect mind and memory blessed by Almighty God, for the same, do make and problish this my last will and Testament in manner and form following, that is to say:

First I lend my land and plantation whereon I now live unto my beloved wife, Sarah Boothe, but desire my son Joseph Boothe may have the liberty of living on the same as he has been accustomed to do. I lend to my beloved wife my stock of every description also my household and kitchen farniture also my farming tools. I give to my wife Sarah during her lifetime fourteen negroes namely, Daniel, Harry, Fillas, Man, Black-Beck, Tom, Oliver, Celia, John, James, Yellow-Beck, & Brister, Bartlet & Edmund. I give unto my Grand Daughter namely, Mary Herndon, Daughter of Lewis Herndon, one negro girl Rachel.

Item, I give unto my Daughter Mary Herndon one negro girl name Ferriba Item, I give unto my grand Children namely, Joseph B. Herndon, George Herndon, Lewis W., Mary Herndon, all their mother's part of my estate to be equally divided between them with the exception of the above.

item, I give unto my daughter Rosy Reach, one negro boy named Hembro.
Item, I lend unto Rosy Reach during her lifetime my negro girl named

Brise, after her death, Brise is to belong to her Daughter Mary Yates.

I give to my daughter Elizabeth Stone my two negroes name Sam & Mary, frem, I give unto my daughter Emelia George two negroes, namely Sylva and Handy.

Item, I give to my Tabitha Hudson my two negroes namely Tom and Hinsken.
Item. I give to my Daughter Delilah Yates, my two negroes Pat & Isiah.

Item, I give to my daughter Sally George, my two negroes Ed & Peter. I give also to Sally a Bureau after my wife's death.

Item, I give to my son Joseph Boothe after the death of myself and my wife, my land and plantation on which I now live, I also give him one Dollar & Carpenter tools & Still, after the death of myself & my wife, Sarah.

Item, I give unto my son Joseph Boothe my girl Rainy. I wish my fourteen negroes before mentioned which I have lent my wife, after myself and her death to be equally divided between my seven daughters, though my daughter Mary Herndon's children (towit) Joseph, George, Lewis W. & Mary Herndon to be considered as one of the seven daughters. I desire the negroes may not be sold but three uninterested persons may ration them in seven shares & they may draw for them and the highest may pay to the lowest so they have equal shares & I do hereby constitute & appoint my worthy friend William Yates, Sampson Moore & Sarah my wife Executors to this my last will & Testament. In witness whereof I have hereunto set my hand and seal the day and year above written.

JOSEPH BOCTHE^{III}, son of ²³ Joseph and Sarah Boothe, born 6/16/1788²⁴, in North Carolina 25, probably Orange County, married (1) c. 1815, possibly in Orange County, Nancy K. Whitfield, born 6/20/1787, North Carolina; married (2) ante 6/8/1860, Elizabeth, born c. 1790, North Carolina 28.

The following is an accurate copy from a certified copy of page 239, Registered Book 12, recorded 6/10/1836, Wake County, North Carolina; March 12, 1336 --

Know all to whom this may concern that I Resanna Reach do this day relinquish the right of all property that I have bought at the sale of Zacheriah Reach, decid. to Joseph Booth, Jeremiah Morris, Wm. George and others, my recruities to a note that I gave to the administrator for the sum of eight hundred and thirty-five dollars and seventy five cents for the purpose of endermifying them provided they should be in any difficulty in becoming suffers thereby they are at liberty to take to take and dispose of the same in the best manner they can to satisfy the said notes so as to keep from paying anything on my account and also all the estate that falls to me by the death of Zacherich Reach and also the crop that is in hand and may be hereafter raised on the plantation and stock of all kinds including two negroes. Oliver and Man and whenever the said Note is satisfied the Securities is exempt from the payment of the same, then and in that case the said property is relinquished to his, the said Rosanna Reach the right of which will belong to no other person whatenever. Given under my hand and seal the day above written.

Joseph Boothe made his will in Wake County on 3/24/1866 and it was probated in May, 1867. He died 5/4/1867²⁹, Wake County, N.C. Nancy K. (Whitfield) Boothe probably died between 9/19/1850 and 6/8/1860³⁰, probably in Wake County. (There is a will of a Nancy Boothe, Wake Co., 1/20/1843, to which a J. Boothe was a witness. However, it was proven in May, 1844. Since Census records show that our Nancy Boothe was living in 1850, the Nancy Boothe of the will could not have been ours.)

Elizabeth, Joseph's second wife, probably died ante 3/24/1866, as she is not mentioned in his will. An accurate copy from a photostatic copy of his will on file in Will Book 34, page 387, Wake Co., N.C., follows:

In the name of God Amen. I Joseph Boothe of the County of Wake and State of North Carolina, being of sound mind and disposing memory yet considering the uncertainty of life and the certainty of death, do make and declare this my last Will and Testament in manner and form as follows:

Item 1st. I give my body to its mother dust and my soul to the God that gave it me.

2nd. My wish and desire is that my body be buried and my funeral expenses together with my just debts be paid by my executor hereinafter named.

3rd. I give and bequeath all of my real estate, that is all of my lands not otherwise disposed of to be equally divided at ... valuation between the sons of J.W. Boothe and G.J. Boothe and J.W. Boothe and G.J. Boothe being my sons and the heirs to whom I bequeath this property being my grandsons.

4th. I give and bequeath the one half of my personal estate to my daughter Sarah Mildred O. Kelly, and if she should die without an heir of the body to be returned to my estate and equally divided amongst my heirs; And the remaining portion or the other half of said personal estate. I give and bequeath to be equally divided between my granddaughter Henry Ann King and the female children of my sons J.W. Boothe and G.J. Boothe said female children being my grandchildren.

Item 5th. My will and desire is that as I have commenced a crop for the present year that said crop be cultivated by my grandsons James Howard Lowe, George J. Lowe and W.C. Lowe, and that they have the use of my horses and every other farming faculty, and that both horses and the parties aforesaid be boarded out of my estate and all expensis incurred in making said crop be paid out of my estate.

Item 6th. After the crop mentioned in item 5th has been made and gathered my will and desire is that James H. Lowe, George J. Lowe and W.C. Lowe be entitled to and I hereby give to the same (it) to each of them ten barrels of corn and two hundred pounds of each.

Item 7th. I hereby nominate and appoint my beloved son J.W. Boothe my executor to all intents and purposes as witness of my hand and seal. This 24th March A.D. 1866.

JCHN WESLEY BOOTHE ^{IV}, son of ³³ Joseph and Nancy K. (Whitfield) Boothe, was born c. 1817, in North Carolina³⁴, probably in Crange County. As shown by the following census records, he married Tabitha Carroll, c. 3/17/1249, probably in Orange County. According to Ross Boothe, Gonzales, Texas, his father, Joseph Henry Boothe, stated that his father, John Wesley Boothe, served the Confederate States of America.

As shown by census records, Tabitha (Carroll) Boothe, born c. 1824-1825, North Carolina, probably Orange County, was variously called Tabitha, Telitha, Talitha, and "Aunt Bitha" by friends and relatives. John Wesley Boothe was killed by a train 7/4/1898, Cary, N.C. Mrs. Tabitha (Carroll) Boothe died of Pneumonia, 1/--/1909, Cary, N.C., and is buried in the Churchyard of the Reedy Creek Baptist Church.

An accurate copy from a photostatic copy of J.W. Boothe's will -- made 2/15/1897, probated 7/12/1899--on file in Will Book D, page 304, Wake County, North Carolina, follows:

I, John Wesley Boothe of Cary, of the County and State aforesaid, being of sound mind and memory but considering the uncertainty of my earthly existence do make this my last will and testament. First I give and bequeath to my beloved son, John W. Boothe, Jr., my watch.

Second - My will and desire further is that Rebecca Chapell shall have all of my personal property, and I therefore will and bequeath to the said Rebecca Chappell one cow, and my household and kitchen furniture consisting of two feather beds and fixtures, chairs, chests, clock, and one book case, and a my cooking utensils, tables, and one wash pot.

And lastly I do hereby constitute and appoint my trusting friend P.A. Sorrell my lawful Executor to all intents and purposes to execute this my last Will and Testament according to its intent and meaning of the same and every part and clause thereof hereby revoking and declaring atterly void all other Wills and Testaments by me heretofore made in witness whereof I, the said John Wesley Boothe, Sr., do hereunto set my hand and seal this 15th day of Febr. 1897.

Signed, sealed, published by the J.W. Boothe, Sr., to be his last Will and Testament in the presents of us who at his request and in his presents do subscribe our names as witnesses thereto.

W.G. Lowe W.N. Lowe JOSEPH HENRY BOOTHE^V, son of John Wesley and Tabitha (Carroll) Boothe, was named Joseph Henry Lacy Boothe, heartily disliked and dropped "Lacy" and was known all his life as Joseph Henry Boothe. He was born 11/20/1851 in Wake County, North Carolina³⁵.

A graduate of the Raffin-Badger Institute, he came to Gonzales County, Texas, in 1873, to visit his father's brother, George Jeffersen Boethe. He intended returning to North Carolina; however, since he liked this section of Texas so well, he decided to make it his home.

For eight years, he taught schools in Gonzales and DeWitt Counties, residing for a time in Hochheim. Later, he entered the stock business at which he became very successful.

In Gonzales, Texas, on 9/18/1879, Joseph Henry Bootne and Emily James "Jimmie" Lea were married ky Rev. W. Thomas, at the home of her mother. (Gonzales County Court House, Marriage License # 827.) Emily James Lea was born in Carrollton, Mississippi, on 6/22/1853, daughter of James Kennedy Lea, son of Pryor and Maria (Kennedy) Lea; and Dilla Porter Hamon, daughter of John E. and Ruth (Brookes) Hamon³⁶.

In 1886, J.H. Boothe was elected to the Twentieth Legislature, which met during the administration of Governor Roso. In 1890, Joseph was elected Courty Clerk of Gonzales County. After serving as County Clerk for several years, he was elected as Mayor of the City of Gonzales. Inis office he held for five years, resigning c. 1810.

Honest, Bincere, candid, and generous; not generous with money only, but generous also in his judgment of his fellowmen, he bore with the infirmities of others, made allowance for frailties, never said harsh things, and what true friend. He valued friendship for what there was in it and not for what he could get out of it.

Joseph Henry Boothe, one of the most prominent citizens of Gonzales County, died Monday, 8 o'clock p.m., 8/28/1911, while seated on the gallery of his home. Services were held the following Wednesday at 10 o'clock a.m., after which the interment was held at the Masenic Cemetery under the auspices of the Masenic Ledge.

Emily James (Lea) Boothe died Wednesday, 4 o'clock p.m., 1/1/1930, at her home, 706 St. George, Gonzales, Texas. Funeral services were held 1/2/1930 at her home after which interment was made in the Masonic Cemetery.

ROSS BOOTHE^{VI} -- son of Joseph Henry and Emily James (Lea)Boothe, born 7/14/1887 on the Boothe Ranch (now in the vicinity of Five Mile Community) near Gonzales, Texas -- was named for Governor Ross³⁷.

He attended the public schools of Gonzales, later graduating Magna Cum Laude from Bingham School for Boys, Asheville, N.C. He holds a B.A. degree from the University of Texas, where he was a member of the Phi Kappa Psi Fraternity. He earned two Ts in athletics at the University: one in track; one in gym.

In 1909, he returned to Gonzales and entered the hardware business with his father. At the latter's death in 1911, he took his place as a member of the firm of Boothe & Lewis.

In 1917, at the outbreak of World War I, he enlisted in the Air Service. He was sent to Atlanta, Georgia, for special courses in the Georgia School of Technology where he received the commission of 2nd Lieutenant in the Air Service. He was sent to Mineola, Long Island, New York, for further training, later going to St. Paul, Minnesota, and finally to Kelly Field, San Antonio, Texas, where he served until the end of the war.

After the death of Mr. Edward Lewis, Ross Boothe bought Mrs. Lewis' interest in Boothe and Lewis and became sole owner and manager of the Hardware firm. In addition to coming basiness property in Gonzales, Ross Boothe owns a Live Oak County Ranch, stocked with pure bred Hereford Cattle, and a section of land in Nolan County, adjoining his brother's ranch, part of the inheritance from his parents.

Ross Boothe united with the Methodist Church when a young man and has served on the Board of Stewards for years.

Active in many Civic affairs, Ross Boothe served as Chairman of The Gonzales Centennial Committee, which secured the memorial building in Gonzales, the monument at Cost, and appropriate markers erected to Texas herees. He was organizing president of the Gonzales Production Credit Association and an organizer of the Gonzales County Savings and Loan Association. He re-opened the Gonzales Cotton Mill and served for a time as president of the newly formed corporation. A member of the Chamber of Commerce, Mr. Boothe has served as chairman of the Good Roads, Parks, and Waterways Committees. For the past year, he has donated space in the Farmers National Bank Building for a Teen Center.

His outstanding achievement was the erganization in 1937 of the Gonzales Warm Springs Foundation, now known as the Gonzales Warm Springs Rehabilitation Foundation. President for 21 years, he has watched it grow from a simple beginning to the fine Foundation it is today. According to Gonzales Warm Springs Rehab Review v. 3, #10, (9/20/1957), p. 2, if it hadn't been for the efforts and perseverance of Ross Booths, there would be no Warm Springs

Foundation in existence today! His name is listed on the original Charter issued to the Foundation by the Secretary of State.

In addition to being a Rotarian, a Shriner, and a 33 degree Mason, Ross Boothe is a member of: the Patrick Henry (Austin, Texas) Chapter, Sons of the American Revolution, National # 41716, State # 253; the Fleur-de-lis (Austin, Texas) Chapter, Huguenot Society of Texas, # 117; the Mississippi Branch of the Huguenot Society of the Founders of Manakintowne, Virginia, # 61; and the Somerset (Philadelphia, Pa.) Chapter, Magna Charta Barons.

On 6/16/1930, Ross Boothe and Lucile Bennet were married by Rev. D.L. O'Neal, pastor of the Presbyterian Church, at her brother Joei's home, Bastrop, Louisiana. Lucile Bennet was born at her grandfather Blackwell's home, near Hochheim, Texas, 8/18/1898, daughter of Valentine Bennet, son of Capt. Miles Squier and Bathsheba (Gipson) Bennet; and Zorah Harland Blackwell, daughter of John Harland and Sarah Alison (Baker) Blackwell. Biographies of these early Texas families may be read in Johnson and Barker, Texas and Texans, v. 4, pp. 1809-1812; 1898-1900.

Lucile Bennet's education: graduate of Cuero High School, 1916; student Texas Presbyterian College, Milford, Texas, 1916-1917; summer student, the University of Mexico, 1922; summer student, University of Colorado, 1924; B. A. Degree from Southwest Texas State Teachers College, San Marcos, Texas, 8/25/1927.

Lucile Bennet spent nine years in the teaching profession in Texas, except for part of one year in Crossett, Arkansas.

For many years, she was a member of the Presbyterian Church at Hochheim Texas, serving as planist and working with the youth group.

After her marriage to Ross Boothe, 6/16/1930, she became a member of the First Methodist Church in Gonzales. She has been Superintendent of the Childrens Division of the Methodist Sunday School for 14 years. A member of the Womans Society of Christian Service, Lucile was awarded a life membership pen.

She served faithfully for years as County Chairman of Highway Beautification and, at her suggestion, Crepe Myrtle was planted from the city limits to the First Shot Monument at Cost. niThe Rock Entrance South of Gonzales was erected by the Highway Department, in co-operation with her committee. Her seven years' chairmanship of the Gonzales Memorial Museum Committee was largely responsible for transforming a disorderly collection of relicts into a well organized display of Texana. It was her suggestion as chairman and her committee's action that prompted the city's interest in restoring the old Eggleston House. She was also appointed by the County Judge to serve as Chairman of the Gonzales Division of the Texas State Historical Survey Committee.

For a time, a member of the Mother's Study Club, she now holds active membership in the Woman's Study Club and the Wednesday Bridge Club.

Lucile (Bennet) Boothe has served as vice-Regent, Corresponding Secretary, and Chaplain of the Thomas Shelton Chapter, Daughters of the American Revolution, National # 341495. She is Organizing Senior President of the Joseph Boothe Society, Children of the American Revolution, and Reactivating President of the Gonzales Chapter, Daughters of the Republic of Texas. She is a member of the Order of Americans of Armorial Ancestry, National # 256. At one time a member of the Louisiana Society, Colonial Dames of the KVII Century, she is now a member of Houston Chapter VII, Colonial Dames of America. She also holds an associate membership in the San Antonio Conservation Society.

ROSS BOOTHE, JR. VII, son of Ross and Lucile (Bennet) Boothe, was born 10/14/1940, San Antonio, Texas, in the Medical and Surgical Memorial Hospital, Monday, at 11:15, A.M. 38

Ross was baptized on Easter Sunday, 1941, by Rev. K.C. Minter, pastor of the First Methodist Church, Gonzales, Texas.

Entering the Central Ward Elementary School in 1946, he was graduated to Junior High School on 5/29/1952.

He was received into the membership of the First Methodist Church by Rev. Charles Marshal on 3/25/1951.

His hobbies include: genealogy, history, photography, music (organ, piano, cornet, baritone), swimming, golf, and water skiing.

Ross won first prize for the best essay on the "Significance of October 2, 1835, in Texas History," October 2, 1957, and he has written articles for the Junior Historian Magazine and the Children of the American Revolution Magazine.

APPENDIX A

Mrs. Seaman was the first member of the N.S.D.A.R. on the record of Joseph Boothe and Mrs. Smith was the first on the record of Daniel Boothe; see footnote # 1.

In an attempt to prove the dates of Daniel and Priscilla Boothe, and Joseph and Sarah Boothe, I telephoned Mrs. Eugene Gray Smith, Mount Airy, North Carolina. I asked her from what sources she got her data and she replied that her D.A.R. papers had been filled out by Cornelia Norris. Mrs. Smith further stated that Cornelia Norris loved genealogy and completed many application forms. Since Cornelia Norris had died, Mrs. Smith thought that her descendant Mrs. Willa McKimmon might have her records. I contacted Mrs. Willa McKimmon, Sheraton Apartments, Raleigh, N.C., phone number TE 2-7675. Mrs. McKimmon did not have documentation of the dates either.

I feel that although there seems to be no further documentation of these dates than the D.A.R. papers, these dates are consistent with all data on the Boothe family.

APPENDIX

Herndon Hunt & Allied Families, p. 95, states that Joseph H. Boothe was born June 16, 1778. First, it is necessary to state that there is no proof that he had a middle initial "H," because nothing calls him Joseph "H" except Herndon Hunt and Allied Families. In his father's will, he calls him Joseph; in his own will, he calls himself Joseph; in a transaction with his sister Rosanna Reach, he is called Joseph; in all census records, he is called Joseph; and in a deed (to be mentioned hereafter) his grandson, Joseph Henry Boothe calls him Joseph. Therefore, since reliable evidence shows that he was Joseph, the "H" must be rejected as an error. Second, the 1778 birth date is incorrect because the 1850 Census (also 1860 Census) establishs that he was born in 1788. The month and day 3s given in the Herndon Hunt & Allied Families are accepted, for no evidence has been produced to show that they are wrong. Therefore, his birth date is given as 6/16/1788.

The birth date of Nancy K. (Whitfield) Boothe, 6/20/1787, given on page 95 of Herndon Hunt & Allied Families, is documented by the 1850 Census of Crange County, N.C. Although the middle initial of Nancy Whitfield is given on page 95 as "H," the Bible of George Jefferson Boothe (see Appendix D) shows clearly that her middle initial was "K."

The marriage date of Joseph and Nancy K. (Whitfield) Boothe has been approximated as c. 1815, because their first child, John Wesley Boothe, was born c. 1817. (See J. W. Boothe, Census 1860, & affidavits of G.O. Boothe.)

The birth records of Joseph Boothe, Nancy K. (Whitfield) Boothe, and their grandchildren, children of John Wesley and Tabitha (Carroll) Boothe, were copied from the Bible of John Wesley Boothe, Sr., by Alma Boothe, daughter of John Wesley, Jr., and Demerius (Sorrelle) Boothe, Cary, N.C. Alma Boothe sent the data to Mrs. Nesbitt, compiler of the Boothe section of Herndon Hunt and Allied Families. The Boothe Bible was lost while in the possession of Alma Boothe; therefore, the dates given in the above mentioned book can not be checked for accuracy. I feel, however, that the dates, as corrected, are true and accurate.

The following Warranty Deed is valuable because it states that Nancy was the wife of Joseph Boothe and it shows that Joseph Henry Boothe was the son of John Wesley and Tabitha (Carroll) Boothe.

It is suggested that when written in longhand, the "h" of Joseph was slightly separated from the "p," and that it was carelessly miscopied as Joseph "H."

Lowe; Fifty acres to George Lowe; Fifty acres to W.C. Lowe; Fifty acres to George Boothe; Semeity Four acres to John W. Boothe, Jr., & one fourth of an acre that is set aside for a burial ground, and which is to contain the graves of Joseph Boothe, Sr., and his wife Nancy and other relatives. (The boundries of this one fourth acre is to be agreed upon and worked by J.W. Boothe, Jr., and K.B. Johnson of his agent.) The land here intended to be conveyed is supposed to contain Three Hundred Twenty Two & 5/16 acres more or less.

To have and to hold the above described premises, together with all and singular, the rights and appurtenances thereto in anywise belonging, unto the said K.B. Johnson and his heirs and assigns forever. And, we do hereby bind our heirs, executors and administrators, to warrant and forever defend, all <code>cnd</code> singular, the said premises unto the said K.B. Johnson and his heirs and assigns, against every person whomsoever lawfully claiming or to claim the same, or any part thereof.

Witnesseth that said Joseph Boothe for and in consideration of the sum of Six Thousand Dellars to him in hand paid by the said Turner & Jones the receipt whereof is hereby acknowledged hath and by these presents he doth bargain and sell alien release and confirm unto the said Turner & Jones their several heirs and assigns forever a tract of land lying partly in said County of Orange and partly in the County of Wake on both sides of North East Creek adjoining the lands of Lewis Herndon Ezekiel George and others Beginning at a stake Lewis corner running thence his line East 11 chains 40 links to a pine tree thence North 71 chains to a post oak thence west Herndon & Georges line 68 chains 60 links to a pine thence South \$7 chains 15 links to a stake thence East 57 chains 25 links to pointers thence North $13^{1/2}$ chains to the beginning. All of said tract except the Grave Yard. And also the steam saw mill and every part thereof. To have and to hold the said land (except the Grave Ward) with all and singular the improvements thereon and appurtenances therewas belonging together with the sd. steam saw mill unto them the sd Turner & Jones their several heirs and assigns forever and the said Boothe for himself and his heirs covenants and promises to and with the sd. Turner & Jones their heirs and assigns that he the said Booth hath a perfect title to sd lands premises and saw mill and the right to convey the same and that he and the heirs shall and will forever warrant and defend the title to so lands and say mill unto the sd. Turner & Jones their several hears and assigns against the claim of claims of all manner of persons whatever.
