The Adams Hamily.

HIS family of **Xdams**, of **Brooklyn**, N. Y. is descended from a family of great respectability, which, at an early period, settled in the Northern-Neck of Virginia, where it became possessed, by grants and purchase, of considerable landed estate.

The exact date at which the family came to America, or whence they came, can now no longer be ascertained, owing to the mutilation, and in some instances total destruction, of county records in this portion of the State during the late war.

The first mention we find of the name of **Adams** in the Northern-Neck, is in a grant to **John Adams** of 393 acres of land in Stafford County, in April, 1705, his will (now destroyed) being recorded in 1730. From 1726 down, we find many grants, amounting in the aggregate to several thousand acres, to different members of the family, until we come to

XUPONIPHO XOANNS of Fairfax Co., Virginia, the first direct ancestor of whom we have any authentic information. He was born in 1721, and settled in Fairfax Co. on lands lying between the North and

South Branches of "Little Hunting Creek." This was in the neighborhood of "Mount Vernon," and the family frequently visited at the home of Washington. In 1749 we find our ancestor appointed sole executor of the will of his cousin William Godfrey of Fairfax Co., whose real estate he inherited. In this will, mention is also made by Godfrep. of his cousins "George and Josins Adams" in Maryland, which would seem to indicate that at least some of the family originally settled in that State. In 1760, we find a grant from Lord Fairfax, Proprietor of the Northern-Neck, to Abconcoo Adams, for 100 acres of land in Fairfax Co., and in 1763, a lease from the latter to one John McIntosh, of Colchester, of 190 acres. Mr. 30ams was a "Planter," and a man of substance for the times in which he lived. He married three times; his first wife (by whom he had three sons) being a Miss Peake * of Virginia, the descendant of a family of great antiquity in England, tracing back to A. D. 1284, temp: Edward I. and the Conquest of Wales. Of this family Sir Robert Dealic was with Charles I. at the Battle of Naseby, and Major Henry Dealie in the Cavalry Service with Prince Rupert, while Sir William Deathe was Lord Mayor of London in 1668. The name of Mr. Adams' second wife we have not been able to ascertain. His third wife was Hannah MOSS, member of a family of distinction in Fairfax Co., several representatives of which have filled the position of Clerks of the County.

Abednego Adams died on his plantation, near Centreville, on the 1st November, 1809, at the advanced age of 88 years, and in his will, executed 28th June, 1804, he mentions the following children:

Josias Prake Zoams, of Loudoun Co., Va., son of Abednego Adams of Fairfax Co., was born about the year 1748. He was a Merchant and Land-holder, possessing large estates in Virginia and Kentucky. In 1791, being then a middle-aged man and a batchelor, he married Elizabeth Price, daughter of Benjamin Crump, of Fauquier Co., member of a family of wealth and distinction in the State.

Mr. **Adams** died at Centreville, Fairfax Co., in November, 1796, and by his marriage with Miss **Crump** (who was born in 1773, married secondly, Capt. Anthony Hughes, by whom she had issue, and died in Jefferson City, Mo., 21st July, 1845) had issue:

(2.) William (bodfrey, of Alexandria, Va., born 9th October, 1795. He was educated at Newtown, Va., and joined his brother Francis in business at Alexandria, but his health failing rapidly, he went to Europe, and resided for some years in Marseilles. About the end of the year 1820, he returned to Alexandria, where he died, unmarried, 27th January, 1821, aged 23 years, bequeathing his estate, real and personal, to his nephew, Wm. Newton

Adams, and his niece, Jane N. Adams.

Mrs. Chas. W. Woolsey of New York thus writes of him in 1869:—"He was slightly built, his health being always delicate. He had the features and hue of a Spaniard; very black eyes and hair, and very much given to segars; an 'exquisite' in the matter of dress, and always the 'gentleman.'"

Francis Xdams, of Alexandria, Va., and Matanzas, Cuba, son of Josias Peake Adams, was born in Centreville, Fairfax Co., 22d July, 1793, and was educated at Newtown, Va. About 1813 he established himself in Alexandria, under the firm name of Adams, Herbert & Co., with a branch house in Norfolk, and did an extensive shipping and commission business. On the 20th December, 1814, he married Mary Ricketts, daughter of William **Acwton** of Alexandria, Va., and sister of Commodore John Thomas Ilcuton, U. S. N. This family of Icwton, one of the oldest and most aristocratic in Virginia, is descended from John Ichoton, Lord Mayor of the City of York, England, abt. 1600, whose ancestor, Sir Ancel (DOTMAN, overcame and took captive a Moorish Prince at the battle of Ascalon in 1192. For this, and other deeds of valor, he received many marks of favor from Richard "Coeur de Lion;" among others, he was permitted to bear as his crest the figure of a Prince kneeling and surrendering his sword.

From 1815 to 1818, Mr. **Adams** was vestryman of "Christ Church," Alexandria, where William **Adams** had been a warden from 1765 to 1775, in the same vestry with Genl. Washington. He served in the War of 1812, his widow afterwards receiving for his services a grant of 160 acres of land. His health failing, he made several voyages to Europe and the West Indies; was appointed U. S. Consul at Trieste,

Austria, 3d March, 1819. He finally settled in Matanzas, Cuba, establishing himself under the firm of Latting, Adams & Stewart, and bought a coffee estate across the bay from the city, which he called "Mount Vernon." He was appointed "U. S. Consular Commercial Agent" at Matanzas 8th August, 1823, and died at "Mount Vernon" 3d May, 1825, Aged 32 years, being buried on the estate.

Mrs. Chas. W. Woolsey of New York, thus describes him:—"Mr. Francis **Adams** was a man of rare purity of mind and morals; of great refinement; a charming companion in social and domestic life; highly cultivated and accomplished, and all this combined with very unusual business abilities and a most winning and gentlemanly address, which made him friends of all who knew him."

By his marriage with Miss **Hewton** (who was born in Alexandria, 12th March, 1795, died in Brooklyn, N. Y., 27th February, 1869, aged 75 years, and is buried at Norwich, Conn.) he had issue:

William Delufon Xdams, of Brooklyn, N. Y., son of Francis Adams, was born in Alexandria, Va., 15th September, 1818. He is a merchant, having received his mercantile education in the house of Messrs. G. G. & S. Howland of New York, Mr. Gardiner Greene Howland having been his guardian. When about 19 years of age he went to Venezuela, where he engaged in business for some years, and married, on the 29th September, 1844, Doña Maria del Cármen, daughter of Don Vicente de Mithelena y Rojas of Caracas, Administrator of Customs at Laguayra and President of the Tribunal de Comercio at Caracas, a descendant of the ancient family of "de Michelena," of the Valley of Oyarzun, in the Province of Guipuzcoa, whose "Casa Solariega," or manor-house, is in the town of Goizueta, Province of Navarra, Spain.

In 1848, Mr. Mams went to the Island of Cuba and became a partner of the well-known house of Messrs. Brooks & Co. of Santiago de Cuba. He was for many years United States and Venezuelan Consul at that place, President of the Philharmonic Society, and a leader in social as well as business circles.

In 1865 he returned to his native country, and became a partner of the house of Messrs. Moses Taylor & Co. of New York. He resides on Brooklyn Avenue, Brooklyn; is connected with "St. Andrew's" Episcopal Church as vestryman, and is one of its principal supporters.

By his marriage with Miss Mithelena (who was born in Caracas, 16th July, 1824, died in Santiago de Cuba, 19th November, 1871, and is buried in the family lot at Norwich, Conn.) he has issue:
